The Secretary of State, in exercise of the powers conferred on him by section 77(1) and (4) of the Education (Scotland) Act 1980(a) and of all other powers enabling him in that behalf, hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Glasgow College of Technology and Robert Gordon's Institute of Technology (Change of Name) Regulations 1990 and shall come into force on 31st December 1990.

Change of name of the institutions

2.—(1) Glasgow College of Technology shall be re-named and known as "Glasgow Polytechnic".

(2) Robert Gordon's Institute of Technology shall be re-named and known as "The Robert Gordon Institute of Technology".

Amendment of the Regulations governing Glasgow College of Technology

3.—(1) In regulation 2 of the Glasgow College of Technology (No. 2) Regulations 1985(b) for the definitions of "College" and "governing body" there shall be substituted the following definitions:—

 "“College” means Glasgow Polytechnic;

 “governing body” means the Governors of Glasgow Polytechnic;”.

(2) In regulation 3 of those Regulations, for the words “the said name” there shall be substituted the words “the name of “The Governors of Glasgow Polytechnic””.

(3) In regulation 9(1) of those Regulations, for the words “Glasgow College of Technology” there shall be substituted the words “Glasgow Polytechnic”.

Amendment of the Regulations governing Robert Gordon's Institute of Technology

4.—(1) In regulation 2(1) of the Central Institutions (Scotland) Amendment Regulations 1981(c), for the words “Robert Gordon's Institute of Technology” there shall be substituted the words “The Robert Gordon Institute of Technology” and for the words ““The Governors

of Robert Gordon's Institute of Technology"" there shall be substituted the words ""The Governors of The Robert Gordon Institute of Technology"".

(2) In regulation 10(1) of those Regulations, for the words "Robert Gordon's Institute of Technology" there shall be substituted the words "The Robert Gordon Institute of Technology".

(3) In column (3) of each of paragraphs 22 and 30 of the table in Schedule 2 to those Regulations, for the words "Robert Gordon's Institute of Technology" there shall be substituted the words "The Robert Gordon Institute of Technology".

Amendment of the Central Institutions (Scotland) Regulations 1988

5. In regulation 18(2) of the Central Institutions (Scotland) Regulations 1988(a), for the words "Glasgow College of Technology", there shall be substituted the words "Glasgow Polytechnic".

Supplementary

6. Any reference in a scheme, agreement, deed, bond, instrument or other writing, operative or effective immediately before the coming into force of these Regulations—

- (a) to Glasgow College of Technology or to the Governors of Glasgow College of Technology shall be read as a reference to Glasgow Polytechnic or to the Governors of Glasgow Polytechnic respectively;
- (b) to Robert Gordon's Institute of Technology or to The Governors of Robert Gordon's Institute of Technology shall be read as a reference to The Robert Gordon Institute of Technology or to The Governors of The Robert Gordon Institute of Technology respectively,

and any like reference to the College, to the Institute or to the Governors shall be construed accordingly; and no rights, interests, obligations or liabilities of any person shall be affected by these Regulations.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations re-name Glasgow College of Technology as "Glasgow Polytechnic" and Robert Gordon's Institute of Technology as "The Robert Gordon Institute of Technology" and make consequential amendments to relevant Regulations.
