## **BETTING, GAMING AND LOTTERIES**

The Betting, Gaming and Lotteries Act 1963 (Variation of Fees) (No. 2) Order 1991

Made - - - - 30th September 1991
Laid before Parliament 7th October 1991
Coming into force - 2nd December 1991

In pursuance of paragraph 20(1A) of Schedule 1 to the Betting, Gaming and Lotteries Act 1963(1) I hereby make the following Order:

- 1.—(1) This Order may ce cited as the Betting, Gaming and Lotteries Act 1963 (Variation of Fees) (No. 2) Order 1991 and shall come into force on 2nd December 1991.
  - (2) This Order shall not extend to Scotland.
- **2.** Paragraph 20(1) (grant or renewal of permit or licence) of Schedule 1 (bookmaker's permits, betting agency permits and betting office licences) to the Betting, Gaming and Lotteries Act 1963 shall be amended by the substitution, for paragraphs (a) to (e), of the following paragraphs:
  - "(a) in the case of the grant of a bookmaker's permit, £133;
  - (b) in the case of the grant of a betting agency permit, £133(2);
  - (c) in the case of the grant of a betting office licence, £106(3);
  - (d) in the case of the renewal of a bookmaker's permit or betting agency permit, £16(4)
  - (e) in the case of the renewal of a betting office licence, £20(5);".
- **3.** The Betting, Gaming and Lotteries Act 1963 (Variation of Fees) Order 1987(6) is hereby revoked.

## **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order increases certain fees payable in England and Wales to the appropriate authority under paragraph 20(1) of Schedule 1 to the Betting, Gaming and Lotteries Act 1963. The fees for the grant of a bookmaker's permit (paragraph 20(1)(a)) and for the grant of a betting agency permit (paragraph 20(1)(b)) are increased from £100 to £133, and the fee for the grant of a betting office licence is increased from £80 to £106 (paragraph 20(1)(c)). The fee for renewal of a bookmaker's permit or betting agency permit is increased from £12 to £16 (paragraph 20(1)(d)) and the fee for renewal of a betting office licence is increased from £15 to £20 (paragraph 20(1)(e)).
