 - (i) a requirement, on request on or after 1st March 1992 by a person specified in section 5(1) of the Act to display the dog's tattoo pusuant to paragraph (h) to such a person."]

EXPLANATORY NOTE

This Order amends the Dangerous Dogs Compensation and Exemption Schemes Order 1991 by adding to the requirements which must be included in a certificate of exemption requirements that evidence of a dog having been tattooed in the prescribed manner be produced to the Agency appointed by the Secretary of State before 1st March 1992; and that from that date, the tattoo be displayed on request by an authorised person.
