The Enterprise (Scotland) Consequential Amendments Order 1991

Made	28th February 1991
Laid before Parliament	11th March 1991
Coming into force	lst April 1991

Whereas the consequential modifications of provisions in subordinate legislation effected by this Order appear to the Secretary of State to be necessary or expedient in connection with functions becoming, by section 1(a)(ii) and (b)(ii) of the Enterprise and NewTowns (Scotland) Act 1990(1), functions of Scottish Enterprise and Highlands and Islands Enterprise:

Now, therefore, the Secretary of State, in exercise of the powers conferred upon him by section 38(3) of the said Act and of all other powers enabling him in that behalf, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Enterprise (Scotland) Consequential Amendments Order 1991 and shall come into force on 1st April 1991.

General amendments

2. Each of the instruments specified in column (1) of the Schedule to this Order shall be amended by inserting in the instrument, where indicated in column (3) of that Schedule, the words "or section 2 of the Enterprise and New Towns (Scotland) Act 1990".

The Social Security (Credits) Regulations 1975

- 3. The Social Security (Credits) Regulations 1975(2) shall be amended as follows:-
 - (a) in regulation 7(2)(b), after "1973" there shall be added the words "or the Enterprise and New Towns (Scotland) Act 1990"; and
 - (b) in regulation 8(1)(a)(ii)(a), after "1973" there shall be added the words "or section 2(3) of the Enterprise and New Towns (Scotland) Act 1990".

The Social Security (Overlapping Benefits) Regulations 1979

- 5. The Social Security (Overlapping Benefits) Regulations 1979(4) shall be amended as follows:
 - (a) in the definition of "training allowance" in regulation 2(1), the words "Scottish Enterprise, Highlands and Islands Enterprise or" shall be added after the words "on behalf of" (in all three places where they appear); and
 - (b) in regulation 10(1)(h), after "1973" there shall be added the words ", or by Scottish Enterprise or Highlands and Islands Enterprise under section 2 of the Enterprise and New Towns (Scotland) Act 1990,".

The Social Security (Unemployment, Sickness and Invalidity Benefit) Regulations 1983

EXPLANATORY NOTE

(This note is not part of the Order)

The Enterprise and New Towns (Scotland) Act 1990 created in Scotland two new public bodies to be known as Scottish Enterprise and Highlands and Islands Enterprise. As from 1st April 1991, these bodies will assume responsibility for training arrangements in Scotland previously made by the Secretary of State for Employment under the Employment and Training Act 1973 (c. 50). This Order consequentially amends references in subordinate legislation to the Secretary of State and that 1973 Act so as to include, as from 1st April 1991, references to Scottish Enterprise and Highlands and Islands Enterprise and to the Enterprise and New Towns (Scotland) Act 1990.
