The Sea Fish Industry Authority (Levy) (Amendment) Regulations 1990 Confirmatory Order 1991

Whereas the Sea Fish Industry Authority (hereinafter referred to as "the Authority") has made the Sea Fish Industry Authority (Levy) (Amendment) Regulations 1990 (hereinafter referred to as "the Regulations");

And whereas the Authority has transmitted to the Minister of Agriculture, Fisheries and Food and the Secretaries of State respectively concerned with the sea fish industry in Scotland, Wales and Northern Ireland (hereinafter referred to as "the Ministers") the objections to the Regulations which have been duly made to the Authority and have not been withdrawn and the Ministers have considered such objections;

And whereas the Ministers, after consultation with the Authority, have considered it desirable to make modifications in the Regulations and have caused notice of those modifications to be published in such manner as they thought best adapted for informing persons affected;

Now, therefore, the Ministers, in exercise of the powers conferred on them by sections 4(2) and (10) and 14(1) of the Fisheries Act 1981(1) and of all their other enabling powers, hereby make the following Order:

Title and commencement

1. This Order may be cited as the Sea Fish Industry Authority (Levy) (Amendment) Regulations 1990 Confirmatory Order 1991 and shall come into force on 1st April 1991.

Modification and confirmation

2. The Regulations, having been modified by the Ministers, are hereby confirmed and the Regulations as modified are set out in the Schedule to this Order.

SCHEDULE

Article 2

THE SEA FISH INDUSTRY AUTHORITY (LEVY) (AMENDMENT) REGULATIONS 1990, AS MODIFIED

Whereas it appears to the Sea Fish Industry Authority (hereinafter referred to as "the Authority") that it is desirable to increase the existing rate of levy for the purpose of financing its activities;

Now, therefore, the Authority, in exercise of the powers conferred on it by section 4 of the Fisheries Act 1981(2), hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Sea Fish Industry Authority (Levy) (Amendment) Regulations 1990 and shall come into force on the day on which the confirmatory Order by Ministers comes into force.

Interpretation

2. In these Regulations "principal Regulations" means the Sea Fish Industry Authority (Levy) Regulations 1988 which are set out in the Schedule to the Sea Fish Industry Authority (Levy) Regulations 1988 Confirmatory Order 1989(**3**).

Amendment of principal Regulations

3. For the Schedule to the principal Regulations there shall be substituted the following Schedule—
