The Child Abduction and Custody (Parties to Conventions) Order 1992

Made - - - 11th February 1992

At the Court at Buckingham Palace, the 11th day of February 1992 Present,

The Queen's Most Excellent Majesty in Council

Her Majesty, in exercise of the powers conferred on Her by section 2 of the Child Abduction and Custody Act 1985(1), is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

- 1.—(1) This Order may be cited as the Child Abduction and Custody (Parties to Conventions) Order 1992.
- (2) The Child Abduction and Custody (Parties to Conventions) (Amendment) (No. 4) Order 1991(2) is revoked.
- **2.** For Schedule 1 to the Child Abduction and Custody (Parties to Conventions) Order 1986(**3**) there shall be substituted the following—
