The Registration of Births, Deaths  
and Marriages (Fees) Order 1992

The Secretary of State for Health, in exercise of the powers conferred by section 5(1) and (2) of, and paragraphs 1 and 2 of Schedule 3 to, the Public Expenditure and Receipts Act 1968<sup>(1)</sup> and now vested in him<sup>(2)</sup> and of all other powers enabling him in that behalf, hereby makes the following order:

**Citation and commencement**

1. This Order may be cited as the Registration of Births, Deaths and Marriages (Fees) Order 1992 and shall come into force on 1st April 1992.

**Fees payable**

2. The fees payable in England and Wales under each of the enactments specified in column 2 of the Schedule to this Order in respect of the matters specified in column 2 shall be the fees specified in relation thereto in column 4 and each of those enactments shall have effect accordingly.

(2) Article 2 of the Secretary of State for Social Services Order (see S.I. 1968/1699) transferred all functions of the Minister of Health to the Secretary of State for Social Services and article 2(1) of the Transfer of Functions (Health and Social Security) Order 1988 (see S.I. 1988/1843) transferred certain of those functions, including those in relation to registration of births, deaths and marriages to the Secretary of State for Health.

### **Revocation of Order**

The provisions of this Order shall have effect in place of the provisions of the Registration of Births, Deaths and Marriages (Fees) (No. 2) Order 1992<sup>(3)</sup> (under which the fees payable were as respectively set out in column 5 of the Schedule to this Order) and that Order is accordingly revoked.

#### EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order specifies the fees payable for the year beginning 1st April 1992 under the Acts relating to the registration of births, deaths and marriages and associated matters.

The fee increased are those payable under sections 27(6) and (7), 32(5), 41(6), 51(1) and (2) and 57(4) of the Marriage Act 1949.

Otherwise the fees payable from 1st April 1992 are the same as those payable from 1st April 1991.
