**The Royal Bournemouth and Christchurch Hospitals National  
Health Service Trust (Transfer of Trust Property) Order 1993**

The Secretary of State for Health, in exercise of the powers conferred on her by section 92(1) of the National Health Service Act 1977<sup>(1)</sup> and of all other powers enabling her in that behalf, having regard to the change in the arrangements for the administration of hospitals and facilities formerly managed by East Dorset Health Authority resulting from the establishment of the Royal Bournemouth and Christchurch Hospitals National Health Service Trust<sup>(2)</sup>, having consulted that Health Authority and that Trust in accordance with section 92(3) of that Act, hereby makes the following Order:

**Citation, commencement and interpretation**

1.—(1) This Order may be cited as the Royal Bournemouth and Christchurch Hospitals National Health Service Trust (Transfer of Trust Property) Order 1993 and shall come into force on 22nd March 1993.

(2) In this Order:

“the Authority” means East Dorset Health Authority;

“the Trust” means the Royal Bournemouth and Christchurch Hospitals National Health Service Trust;

“the trust property” means the items specified in a schedule of trust property prepared by and agreed upon by the Authority and the Trust on 21st January 1993 which schedule has been signed on behalf of both the Authority and the Trust.
