**ROAD TRAFFIC**

**The Road Traffic (Special Parking Areas) (London Boroughs of Richmond upon Thames and Southwark) Order 1993**

*Made* - - - - 23rd December 1993  
*Laid before Parliament* 10th January 1994  
*Coming into force* - - 31st January 1994

Whereas the councils of the London boroughs of Richmond upon Thames and Southwark have each applied to the Secretary of State for an order to be made under section 76 of the Road Traffic Act 1991<sup>(1)</sup> and the Secretary of State has consulted the Commissioner of Police of the Metropolis in accordance with section 76(2) of that Act:

NOW, the Secretary of State for Transport, in exercise of the powers conferred by section 76(1) and section 77(6) of the Road Traffic Act 1991 and of all other powers enabling him in that behalf, hereby makes the following Order:—

**Citation and commencement**

1. This Order may be cited as the Road Traffic (Special Parking Areas) (London Boroughs of Richmond upon Thames and Southwark) Order 1993 and shall come into force on 31st January 1994.

**Interpretation 2.**

In this Order—

“the 1984 Act” means the Road Traffic Regulation Act 1984<sup>(2)</sup>;

“the 1991 Act” means the Road Traffic Act 1991;

a reference in a Schedule to a number followed by the letter “m” is a reference to that number of metres; and

a reference to a Schedule followed by a number is a reference to the Schedule to this Order bearing that number.

### **Designation of special parking areas**

3.—(1) The Secretary of State hereby designates each of the following areas as a special parking area:—

- (a) the London borough of Richmond upon Thames except the roads named or described in Schedule 1; and
- (b) the London borough of Southwark except the roads named or described in Part I of Schedule 2 and the areas described in Part II of that Schedule.

(2) A reference in the following provisions of this Order to a special parking area is a reference to an area designated by this article.

### **Modification of the Road Traffic Regulation Act 1984**

4.—(1) Section 55 of the 1984 Act (financial provisions relating to designation orders) shall have effect in relation to the London boroughs of Richmond upon Thames and Southwark as if—

- (a) at the end of subsection (1) there were inserted the words “and of the income from additional parking charges (within the meaning of section 74(8) of the Road Traffic Act 1991) received by them in respect of vehicles found within a special parking area and the expenditure incurred by them in the discharge of functions exercisable by them in relation to a special parking area by virtue of Part II of the Road Traffic Act 1991”; and
- (b) after subsection (1) there were inserted the following subsection:—

“(1A) In subsection (1) above, references to “a special parking area” are to an area designated as a special parking area by the Road Traffic (Special Parking Areas) (London Boroughs of Richmond upon Thames and Southwark) Order 1993.”

(2) Section 102(2) of the 1984 Act (charges for removal, storage and disposal of vehicles) shall have effect in relation to a vehicle found in a special parking area as if, in paragraph (d), for the words “a parking place” to the end there were substituted—

- “(i) a parking place designated under section 6, 9 or 45 of this Act or otherwise provided or controlled by that authority, or
- (ii) a place where the vehicle was stationary in circumstances in which an offence would have been committed in respect of the vehicle but for section 76(3) of the Road Traffic Act 1991,

as they may require.”

### **Modification of the Road Traffic Act 1991**

5.—(1) Section 70 of the 1991 Act (exemptions from provisions relating to the immobilisation of vehicles in parking places) shall have effect in relation to a vehicle found in a special parking area as if, in subsections (1) and (2), after the words “section 69(1)” there were inserted the words “or section 77(4)”.

(2) Section 71 of the 1991 Act (representations in relation to removal or immobilisation of vehicles) shall have effect in relation to a vehicle found in a special parking area as if, for subsection (4), there were substituted the following subsection:—

“(4) The grounds are—

- (a) that there were no reasonable grounds for the parking attendant concerned to believe that either—
  - (i) the vehicle had been permitted to remain at rest in the parking place in circumstances specified in section 66(2)(a), (b) or (c) of this Act, or

- (ii) the vehicle had been permitted to remain at rest in a special parking area (other than in a designated parking place) in circumstances in which an offence would have been committed in respect of the vehicle but for section 76(3) of this Act;
- (b) that the vehicle had been permitted to remain at rest in the place in question by a person who was in control of the vehicle without the consent of the owner;
- (c) that the place at which the vehicle was at rest was neither a designated parking place nor in a special parking area;
- (d) in a case within subsection (1)(d) above, that, by virtue of an exemption given by section 70 of this Act, neither section 69 nor 77(4) of this Act applied to the vehicle at the time in question; or
- (e) that the penalty or other charge in question exceeded the amount applicable in the circumstances of the case.”

(3) Section 74(8) of the 1991 Act (fixing of certain parking and other charges for London) shall have effect in relation to the London boroughs of Richmond upon Thames and Southwark as if, after the words “section 69”, there were inserted the words “or section 77(4)”.

(4) Section 79(2) of the 1991 Act (application to Crown and visiting forces) shall have effect in relation to a vehicle found in a special parking area as if, for “66 and 69 to 71”, there were substituted “66, 69 to 71, 76 and 77”.

(5) Schedule 6 to the 1991 Act (parking penalties) shall have effect in relation to a vehicle found in a special parking area as if—

- (a) in sub-paragraph (c) of paragraph 2(4), for the words “the parking place” there were substituted the words “the place in question”, and
- (b) in sub-paragraph (d) of paragraph 2(4), the word “designation” was omitted.

ROADS IN THE LONDON BOROUGH OF RICHMOND UPON  
THAMES EXCLUDED FROM THE SPECIAL PARKING AREA

1. A205 South Circular Road between the borough boundary with the London borough of Hounslow at Kew Bridge and the borough boundary with the London borough of Wandsworth at Dyers Lane.

2. A316 between the borough boundary with the London borough of Hounslow at Crane Park and the borough boundary with the London borough of Hounslow at Chiswick Bridge.

*Roads adjacent to A205*

3. Avenue Gardens between its junction with Upper Richmond Road West (A205) and a point opposite the northern building wall of 110 Upper Richmond Road West.

4. Beechwood Avenue between its junction with Mortlake Road (A205) and a point opposite the western rear building wall of 62 Mortlake Road.

5. Burlington Avenue between its junction with Mortlake Road (A205) and a point opposite the north western rear building wall of 46 Mortlake Road.

6. Cambridge Road between its junction with Mortlake Road (A205) and a point opposite the north eastern kerbline of the access road to the rear of 1 to 9 Mortlake Road.

7. Carlton Road between its junction with Upper Richmond Road West (A205) and a point opposite the southern flank wall of 2A Carlton Road.

8. Colston Road between its junction with Sheen Lane (B351) and a point opposite the party wall of 365 and 367 Upper Richmond Road West.

9. Connaught Avenue between its junction with Upper Richmond Road West (A205) and a point opposite the southern flank wall of The Cottage, Connaught Avenue.

10. Courtlands Avenue between its junction with Mortlake Road (A205) and a point opposite the party wall of 2 and 3 Courtlands Avenue.

11. Coval Road between its junction with Upper Richmond Road West (A205) and a point opposite the southern kerbline of Coval Passage.

12. Cumberland Road between its junction with Mortlake Road (A205) and a point opposite the party boundary of 28 and 30 Cumberland Road.

13. Deanhill Road between its junction with Upper Richmond Road West (A205) and a point opposite the northern flank wall of 5 Deanhill Road.

14. Derby Road between its junction with Upper Richmond Road West (A205) and a point opposite the party wall of 4 and 5 Derby Court, Derby Road.

15. East Sheen Avenue between its junction with Upper Richmond Road West (A205) and a point opposite the southern flank wall of 1 East Sheen Avenue.

16. Elm Road—

(a) (east side) between its junction with Upper Richmond Road West (A205) and a point opposite the southern flank wall of 2 Elm Road;

(b) (west side) between its junction with Upper Richmond Road West (A205) and a point opposite the southern flank wall of 1 Elm Road.

17. Forest Road between its junction with Mortlake Road (A205) and a point opposite the north eastern rear property boundary of 41 Mortlake Road.
18. Gilpin Avenue between its junction with Upper Richmond Road West (A205) and a point opposite the southern flank wall of 2A Gilpin Avenue.
19. Gipsy Lane between its junction with Upper Richmond Road (A205) and a point 20m north westwards.
20. Gordon Avenue between its junction with Upper Richmond Road West (A205) and a point opposite the southern flank wall of 4 Gordon Avenue.
21. Graemsdyke Avenue between its junction with Upper Richmond Road West (A205) and a point opposite the southern flank wall of 52 Graemsdyke Avenue.
22. Grosvenor Avenue between its junction with Upper Richmond Road West (A205) and a point opposite the rear building wall of 96 Upper Richmond Road West.
23. Grosvenor Gardens between its junction with Upper Richmond Road West (A205) and a point opposite the southern flank wall of 2 Grosvenor Gardens.
24. Hertford Avenue between its junction with Upper Richmond Road West (A205) and a point opposite the southern flank wall of 2 Hertford Avenue.
25. High Park Road between its junction with Mortlake Road (A205) and a point opposite the party boundary between 13 and 15 High Park Road.
26. Kent Road between its junction with Mortlake Road (A205) and a point opposite the south western kerbline of Kenmore Close.
27. Kew Green—
  - (a) (east arm — north junction) between its junction with Kew Road (A205) and a point opposite the party wall of 106 and 108 Waterloo Place;
  - (b) (east arm — south junction) between its junction with Kew Road (A205) and the southern kerbline of Gloucester Road;
  - (c) (west arm — north junction) between its junction with Kew Road (A205) and a point 20m westwards;
  - (d) (west arm — south junction) between its junction with Kew Road (A205) and a point opposite the party wall of 21 and 23 Kew Green.
28. Kew Road between its junction with Mortlake Road (A205) and a point opposite the party wall of 350 and 352 Kew Road.
29. Kings Road between its junction with Upper Richmond Road West (A205) and a point opposite the rear building wall of 140 Upper Richmond Road West.
30. Kingsway between its junction with Clifford Avenue (A205) and a point opposite the party wall of 143 and 145 Kingsway.
31. Langdale Close between its junction with Clifford Avenue (A205) and the back of the Clifford Avenue footway.
32. Larches Avenue between its junction with Sheen Lane (B351) and a point 10m eastwards.
33. Leconfield Avenue between its junction with Upper Richmond Road (A205) and a point opposite the rear building wall of 484 Upper Richmond Road West.
34. Leinster Avenue between its junction with Upper Richmond Road West (A205) and a point opposite the southern flank wall of 51 Leinster Avenue.

- 41.** Portman Avenue between its junction with Upper Richmond Road West (A205) and a point opposite the southern flank wall of 2 Portman Avenue.
- 42.** Priests Bridge—
- (a) (east arm) between its junction with Upper Richmond Road (A205) and a point opposite the party wall of 2 and 4 Priests Bridge;
  - (b) (west arm) between its junction with Upper Richmond Road West (A205) and a point opposite the western kerblines of Fitzgerald Avenue.
- 43.** Queens Ride—
- (a) (east-west arm) between its junction with Upper Richmond Road (A205) and a point opposite the western flank wall of 1 to 28 Roehampton Court;
  - (b) (north-south arm) between its junction with Upper Richmond Road (A205) and Queens Ride (east to west arm).
- 44.** Queens Road between its junction with Upper Richmond Road West (A205) and a point opposite the rear property boundary of 130 Upper Richmond Road West.
- 45.** Richmond Park Road between its junction with Upper Richmond Road West (A205) and the northern flank wall of 2 Richmond Park Road.
- 46.** Rocks Lane between its junction with Upper Richmond Road (A205) and a point 55m north eastwards.
- 47.** Ruskin Avenue between its junction with Mortlake Road (A205) and a point opposite the north eastern building wall of 67 Mortlake Road.
- 48.** Shalstone Road between its junction with Clifford Avenue (A205) and a point opposite the party wall of 58 and 60 Shalstone Road.
- 49.** Sheen Gate Gardens between its junction with Upper Richmond Road West (A205) and a point opposite the northern flank wall of 1 Sheen Gate Gardens (Pinelees Court).

- 51.** Shottfield Avenue between its junction with Upper Richmond Road West (A205) and a point opposite the party wall of 2A and 2B Shottfield Avenue.
- 52.** Somerton Avenue between its junction with Clifford Avenue (A205) and a point 25m westwards.
- 53.** St Leonards Road between its junction with Clifford Avenue (A205) and a point opposite the party wall of 103 and 105 St Leonards Road.
- 54.** Sutherland Gardens between its junction with Upper Richmond Road West (A205) and a point opposite the southern flank wall of 1 Sutherland Gardens.
- 55.** Taylor Avenue between its junction with Mortlake Road (A205) and a point opposite the southern flank wall of 2 Taylor Avenue.
- 56.** Temple Sheen Road between its junction with Upper Richmond Road West (A205) and a point opposite the northern flank wall of East Sheen Baptist Church.

**96.** Norfolk Close between its junction with Cassilis Road and a point opposite the eastern flank wall of 13 Norfolk Close.

**97.** North Road between its junction with Lower Richmond Road (A316) and a point opposite the southern property boundary of 7 North Road.

**98.** Orchard Road (St Margarets) between its junction with St Margarets Road (A316) and a point opposite the front building wall of 207 St Margarets Road.

**99.** Orchard Road (Richmond) between its junction with Lower Richmond Road (A316) and a point 30m southwards.

**100.** Parkshot—

(a) (west side) between its junction with Twickenham Road (A316) and a point 20m southwards;

(b) (east side) between its junction with Twickenham Road (A316) and a point opposite the northern kerblines of Clarence Street.

**101.** Raleigh Road between its junction with Lower Mortlake Road (A316) and a point 10m northwards.

**102.** Redway Drive between its junction with Chertsey Road (A316) and a point opposite the northern flank wall of 106 Redway Drive.

**191.** Southampton Way between its junction with Peckham Road (A202) and a point 20.5m north of the southern flank wall of the “Oliver Goldsmith Infant and Junior School”.

**192.** St Mary’s Road between its junction with Queen’s Road (A202) and a point 9m north of the northern flank wall of 10 St Mary’s Road.

**193.** St Giles Road between its junction with Peckham Road (A202) and a point 6m north of the front wall of “Longleigh House”.

**194.** Staffordshire Street between its junction with Peckham High Street (A202) and a point 6.5m north of the front wall of 171 Peckham High Street.

**195.** Sumner Road between its junction with Peckham High Street (A202) and a point 11m north of the rear wall of 27 Peckham High Street.

**196.** Sumner Avenue between its junction with Peckham High Street (A202) and a point 4m north of the rear wall of 1 and 3 Peckham High Street.

**197.** Talfourd Road between its junction with Peckham Road (A202) and a point 1.5m south of the party wall of 6 to 8 Talfourd Road.

**198.** Vestry Road between its junction with Peckham Road (A202) and a point 1m south of the party wall of 4 and 5 Vestry Road.

**199.** Vicarage Grove between its junction with Peckham Road (A202) and a point 1m south of the southern flank wall of 1 Vicarage Grove.

**200.** Warner Road between its junction with Camberwell New Road (A202) and a point 1m south of the southern flank wall of 3 Warner Road.

**201.** Wilson Road between the building line of Peckham Road (A202) and a point 8m south.

**202.** Woods Road between its junction with Peckham High Street (A202) and a point 9m south of the front wall of 6 to 8 Cherry Tree Court.

**203.** Wren Road between its junction with Camberwell Church Street (A202) and a point 2m north of the rear wall of 2 Camberwell Church Street.

**204.** Wyndham Road between its junction with Camberwell New Road (A202) and a point 2m south of the northern flank wall of 158 Wyndham Road.

**205.** York Grove between its junction with Queen's Road (A202) and a point opposite the front wall of 217 Queen's Road.

#### *Roads adjacent to A205*

**206.** Alleyn Park between its junction with Dulwich Common (A205) and a point 6m north of the northern flank wall of 121 Alleyn Park.

**207.** College Road between its junction with Dulwich Common (A205) and a point 9m north of the southern flank wall of 41 College Road.

**208.** Croxted Road—

(a) (north arm) between its junction with Thurlow Park Road (A205) and a point 4m north of the northern flank wall of 103b Croxted Road;

(b) (south arm) between its junction with Thurlow Park Road (A205) and a point 24m south of the rear wall of 128 Thurlow Park Road.

**209.** Gallery Road between its junction with Thurlow Park Road (A205) and a point 7m south of the southern flank wall of the property "Brightlands".

**210.** Hambledon Place between the building line of Dulwich Common (A205) and a point 15m south.

**211.** Lordship Lane between its junction with Dulwich Common (A205) and a point 15m north west of the party wall of 481 and 483 Lordship Lane.

**212.** Sydenham Hill between its junction with London Road (A205) and a point 3.5m north of the southern flank wall of 173 Sydenham Hill.

**Status:** This is the original version (as it was originally made). This item of legislation is currently only available in its original format.

**213.** Underhill Road between its junction with Lordship Lane and a point 7m north of the most southern flank wall of “Adams House”.

**214.** Wood Vale between the building line of London Road (A205) and a point 46m north.

#### EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order designates the whole of the London boroughs of Richmond upon Thames (excluding the roads referred to in Schedule 1) and Southwark (excluding the roads and areas referred to in Schedule 2) as special parking areas for the purposes of Part II of the Road Traffic Act 1991 with effect from 31st January 1994. The Order also makes consequential modifications to the Road Traffic Regulation Act 1984 and to Part II of the 1991 Act.
