DESCRIPTIONS OF BOUNDARIES OF ELECTORAL DIVISIONS FOR

Electoral Division 1: Arbroath Central

Commencing at grid reference NO 6307 3990 on MLWS on the eastern boundary of Tayside Region and Angus District at a point in line with the steps at the eastern end of the promenade southeast of the caravan park on Dundee Road, Arbroath; then northwestward in a straight line to the said steps and northwestward along the path to the western side of the playground to the Dundee to Aberdeen railway; then eastward along the said railway to the bridge carrying the railway over Dundee Road at its junction with Viewfield Road then northward and northwestward along Viewfield Road to and southwestward along Arbirlot Road to Emislaw Drive; then generally northwestward along Emislaw Drive to and northeastward along West Way to Keptie Road; then northward along Keptie Road to its junction with Forfar Road then northwestward along Forfar Road to the access road leading to Elmfield Avenue; then northeastward and generally eastward along the said access road and rear curtilages of Nos 18-88, Elmbank Crescent and prolongation of this line to the rear curtilages of Nos 27-51, Elm Hill and the property known as The Elms then southeastward along the eastern curtilage of The Elms and its prolongation in a straight line to Cairnie Road; then southeastward along Cairnie Road to and along Cairnie Street to Guthrie Port; then eastward along Guthrie Port to Fishacre then northeastward along Fishacre to and northward along Culloden Terrace to Hayshead Road; then eastward and generally southeastward along Hayshead Road to Springfield Terrace; then southwestward along Springfield Terrace to and southeastward along Cliffburn Road to the path leading southeastward across Springfield Park; then southeastward along the said path and its prolongation in a straight line across Victoria Park to the eastern boundary of Tayside Region and Angus District; then generally southwestward along the said regional and district boundary to the point of commencement.

Electoral Division 2: Carnoustie East and Arbroath West

Commencing at grid reference NO 5671 3412 on MLWS on the eastern boundary of Tayside Region and Angus District then northwestward in a straight line to the level crossing where the Dundee to Aberdeen railway crosses Station Road, Carnoustie; then continuing northwestward along Station Road to and southwestward along Church Street to Lochty Street; then generally northwestward along Lochty Street and Holyrood Street to Newton Road; then southwestward and westward along Newton Road to the junction of the unclassified road north of the junction of Balmachie Road; then northwestward along the said unclassified road past Clayholes and Lower Balmachie to the A92 road then northeastward along the A92 road to grid reference NO 5501 3665 southwest of the access track to Heugh-head; then northeastward by field boundary and the prolongation of this boundary in a straight line northwestward to its intersection with the Monikie Burn; then northwestward along the said burn to the eastern boundary of the woodland strip due east of the remains of Panmure Castle; then northward and northwestward along the said boundary to the access track leading from the B9128 road to The Mount; then northeastward to and northwestward along the B9128 road to the Boath Burn; then eastward and southeastward along the said burn to the western boundary of the former parish of Arbirlot; then generally northward along the said former parish boundary to the Elliot Water; then generally eastward along Elliot Water to the weir on this water due north of Arbirlot; then in a straight line northeastward to the southern curtilage of Loanend then along the said curtilage to the B9127 road; then northwestward along the said road to its junction with the track leading to Bankhead; then continuing northeastward along the said track past Bankhead to the unclassified road leading from East Muirlands Road, Arbroath to Millfield Feus; then southeastward along said unclassified road and northeastward along the unnamed road past Woodley Caravan Park to the A933 road; then southeastward along the said road to the western boundary of ED 1 (Arbroath Central) then generally southward and southeastward along the said ED boundary to the

eastern boundary of Tayside Region and Angus District; then generally southwestward along the said regional and district boundary to the point of commencement.

Electoral Division 3: Arbroath North and Central Angus

Commencing at grid reference NO 5440 3904 on the northern boundary of ED 2 (Carnoustie East and Arbroath West) where the B9128 road crosses the Boath Burn; then generally northwestward along the said burn and Clearie Burn to the western boundary of the former parish of Panbride; then continuing generally northwestward and westward along the said boundary and the southwestern boundary of the former parish of Carmyllie westward in a straight line to the course of the dismantled railway between Dundee and Forfar; then northwestward along the course of the said railway to the southeastern boundary of the former parish of Forfar; then northeastward and generally northward along the said boundary and the western boundary of the former parish of Dunnichen to the White Burn at its junction with the Vinny Water; then northwestward and northeastward along the White Burn to grid reference NO 4973 4779; then northwestward in a straight line to grid reference NO 4923 4888 on the southernmost point of the southwestern boundary of the woodland strip north of Hillend of Lownie; then northwestward along the said boundary to the path west of Teucherton; then northeastward along the said path to and continuing northeastward along the unclassified road past Teucherton and Mid Dod to the eastern boundary of the former parish of Forfar; then northwestward and northeastward along the said boundary to the course of the dismantled railway between Forfar and Arbroath then westward along the course of the said railway to the access bridge, east of Bowmans Crossing; then northwestward by adjacent field boundary on the north side of the said bridge to the track leading to Home Farm; then northwestward along the said track to a point in line with the southern boundary of the field lying immediately east of Home Farm; then northeastward along the said boundary to and northwestward along the eastern boundary of this field and adjoining eastern field boundaries of fields immediately east of Blackgate to the B9134 road; then northeastward along the said road to where the road crosses the drain east of Howmuir; then northwestward along the said drain and the prolongation of this line to the boundary of the former parish of Aberlemno; then generally northeastward and southward along the western, northern and eastern boundaries of the said parish to the southern boundary of the former parish of Brechin; then generally eastward along the said boundary and the southern boundary of the former parish of Farnell to its junction with the A933 road; then southwestward along the said road to the junction of the unclassified road at Glaster Law; then generally eastward and southward along the said road past Freelands, Muirside of Kinnell then southward through the southeast corner of the disused airfield to the junction of this road and the unclassified road on the northern perimeter of Kinnell; then eastward along the said road to the junction of the access road leading to Hatton Mill and at a point in line with the source of the unnamed burn flowing to the Gighty Burn; then southeastward along the unnamed burn to the Gighty Burn and the northern boundary of the former parish of Inverkeilor; then westward along the said boundary to the B965 road then southeastward along the said road to and southeastward along the access road leading to the gas compression station at grid reference NO 6182 4834 being opposite the northern boundary of the field situated to the north of the gas compression station; then westward to and along the said field boundary to the eastern boundary of the wooded area known as The Kitchen; then southward along the said eastern boundary to and northeastward along the southern boundary of The Kitchen to the field boundary at grid reference NO 6075 4820; then southwestward along the said boundary to the track and access road leading to Leysmill; then southeastward and southwestward along the said track and road to the course of the dismantled railway between Forfar and Arbroath; then southeastward along the course of the said railway to the western boundary of the former parish of Arbroath and St Vigeans; then generally eastward along the said boundary to the junction of the access road leading to West Mains; then northeastward along the said road past West Mains to the track and its prolongation to the track east of Home Farm; then southeastward along the said track and the prolongation of this line southeastward by field boundaries to the Dundee to Aberdeen railway; then southeastward along the said railway to the bridge carrying the unclassified road from Chapelton to Arbroath; then generally

southeastward along the said road past Nether Newbigging to the road at the junction of Brechin Road, Arbroath leading to St Vigeans Parish Church; then southwestward along the said road to the tunnel carrying the Dundee to Aberdeen railway; then southward along the said railway to the bridge carrying Guthrie Port Road, Arbroath on the northern boundary of ED 1 (Arbroath Central); then generally westward along the northern boundaries of EDs 1 and 2 to the point of commencement.

Electoral Division 4: Arbroath East

Commencing at grid reference NO 6545 4095 on the eastern boundary of Tayside Region, Angus District and ED 1 (Arbroath Central) then generally northwestward along the said ED boundary to and generally northward along the eastern boundary of ED 3 (Arbroath North and Central Angus) to the junction of tracks southeast of Home Farm and north of Cauldcots; then northeastward along the track past Cauldcots to the level crossing on the Dundee to Aberdeen railway; then southwestward along the said railway to the southern boundary of the former parish of Inverkeilor; then generally eastward along the said boundary to the unclassified road serving Raesmill and Inchock; then northwestward along the said road to the unclassified road south of Raesmill; then northeastward and southeastward along the said road to the field boundary at grid reference NO 6877 4741; then northeastward along the said boundary, to and continuing northeastward along the northern boundary of South Mains Strip and the prolongation of this boundary in a straight line to MLWS on Kirk Loch at grid reference NO 7055 4807 on the eastern boundary of Tayside Region and Angus District; then southwestward along the said boundary to the point of commencement.

Electoral Division 5: Carnoustie West

Commencing at grid reference NO 5671 3412 on MLWS on the eastern boundary of Tayside Region and Angus District; then generally southwestward and northwestward along the said boundary to the boundary between City of Dundee and Angus Districts; then generally northwestward along the said boundary to the northwestern boundary of the former parish of Monikie; then generally eastward along the said boundary to the Monikie Burn at grid reference NO 4768 4005; then northward by field boundary west of Bractullo to the northern field boundary at grid reference NO 4769 4039; then northeastward in a straight line to grid reference NO 4782 4052 on the northern boundary of the former parish of Monikie; then generally northeastward and southeastward along the said boundary to grid reference NO 4981 4178 on the field drain southeast of Gibsonhall; then southeastward to the extremity of the said drain at grid reference NO 4996 4164; then eastward in a straight line to the field drain south of Gibsonhall at grid reference NO 5015 4165; then generally northeastward and eastward along the line of the said drain to and continuing eastward along the track to the unclassified road southeast of Lawsonhall; then southeastward along the said road to the course of the dismantled railway between Dundee and Forfar on the western boundary of ED 3 (Arbroath North and Central Angus); then generally southeastward along the said boundary to and continuing southeastward along the western boundary of ED 2 (Carnoustie East and Arbroath West) to the point of commencement.

Electoral Division 6: Forfar West

Commencing at grid reference NO 4532 3961 on the western boundary of Angus District at the northern boundary of ED 5 (Carnoustie West) then generally westward along the said district boundary to the Dean Water at grid reference NO 3252 4764; then northwestward to the adjacent track from Braidstone Mill; then northeastward and northwestward along the said track to the unclassified road between Meigle and Glamis; then northeastward and eastward along the said road past Blackhills and Lendrick Lodge to where it crosses the Dairsie Burn at grid reference NO 3644 5116; then generally southeastward along the said burn to the western boundary of the former parish of Kirriemuir; then northeastward along the said boundary to the unclassified road between Meigle and Glamis; then eastward along the said road crossing the A928 road and continuing eastward to a

point in line with the northwest curtilage of Ladywell Sawmills; then northeastward along the said boundary to and continuing northeastward along the track north of Logie Woods to grid reference NO 3911 5174 on the said track; then southeastward by line of drain and field boundaries to grid reference NO 3930 5109; then northeastward along field drain and field boundaries in a straight line to the Gairie Burn; then northward along the said burn to a point in line with the northern field boundary due east of North Mains of Ballindarg; then southeastward along the said boundary and its prolongation in a straight line to the course of the dismantled railway between Forfar and Kirriemuir; then northwestward along the course of the said railway to grid reference NO 4058 5172 in line with the northern boundaries of fields lying west of Padanaram Primary School then northeastward along the said boundaries to the A926 road; then northwestward along the said road to and northeastward along the access road to the track serving Woodhead of Ballinshoe; then southeastward along the said track and continuing southeastward along the western field boundaries west of the said property to grid reference NO 4220 5192; then eastward and northeastward along the southern field boundaries south of Woodhead of Ballinshoe, Mosside of Ballinshoe and East Mosside of Ballinshoe and Nether Bow to the unnamed burn at grid reference NO 4380 5243; then generally southeastward along the said burn to and eastward to the A926 road; then southeastward along said track to and eastward along said road to the course of the dismantled railway between Forfar and Brechin; then eastward along the course of the said railway to a point in line with the northern boundary of Market Muir, Forfar, then southwestward along the said boundary to Brechin Road; then generally southward along Brechin Road and Castle Street to Manor Street; then westward along Manor Street to and southward along the unnamed road leading to Annfield House and continuing generally southward across Myre Road to and along the eastern and southern boundaries of the car park to the lane along the western curtilage of the post office; then southeastward along the said lane to West High Street; then continuing southeastward across West High Street and along new road to and southwestward along St James Road and the A932 Dundee Road to the access road to West Craig Nursery; then northeastward along the said road and continuing northeastward in a straight line along the track to the western boundary of Craig Quarries; then southward and eastward along the said boundary to the western field boundary west of Craignathro at grid reference NO 4546 4843; then southeastward along the western boundaries of fields west of Craignathro to the Spittal Burn at grid reference NO 4569 4689 at the northern boundary of the former parish of Inverarity; then southwestward along the said boundary to the field boundary immediately northeast of Spittalburn; then southeastward along the said field boundary and continuing southeastward along field boundaries across the access road to Wester Meathie and to the Durie Burn; then northwestward along the said burn to the field boundary at grid reference NO 4454 4575; then southwestward along the said boundary to the B9127 road; then generally southeastward along the said road to Inverarity Bridge over the Kerbet Water; then southeastward and eastward along the said water to the access road east of Fotheringham Saw Mill; then northward along the said road to and eastward along the B9127 road to the field track northwest of Seggieden; then northward along the said track to the northern field boundary at grid reference NO 4688 4456; then northeastward in a straight line along field boundaries to the western track access to Little Lour; then southward along the said track to the B9127 road; then eastward along the said road to a point in line with the western boundary of the field west of Whigstreet; then southward along the said boundary in a straight line to the Kerbet Burn; then northeastward along the said burn to the road from Holemill to Whigstreet; then northeastward along the said road and track through Whigstreet Wood to the B9127 road; then eastward along the said road to where the road crosses the dismantled railway running between Dundee and Forfar on the western boundary of ED 3 (Arbroath North and Central Angus) at grid reference NO 4965 4384; then southward along the course of the said railway to the northern boundary of ED 5 at grid reference NO 5066 4172; then southwestward along the said ED boundary to the point of commencement.

Electoral Division 7: Forfar East

Commencing at grid reference NO 4965 4384 on the western boundary of ED 3 (Arbroath North and Central Angus) and the eastern boundary of ED 6 (Forfar West); then generally westward

and northward along the eastern boundary of ED 6 grid reference NO 4282 5218 on the southern boundary of the field south of Mosside of Ballinshoe; then northwestward along the western field boundaries west of Mosside of Ballinshoe and Haughs to the Black Burn at grid reference NO 4216 5372; then generally eastward along the said burn to grid reference NO 4306 5397; then eastward in a straight line to the southwestern boundary of the former parish of Oathlaw; then generally eastward along the said boundary to the Lemno Water; then northeastward along the said water to the western access road to Battledykes; then continuing northeastward along the said road and the field drains running eastward from Battledykes and their prolongation in a straight line to the eastern boundary of Bogindollo Strip at grid reference NO 4645 5571; then southeastward along the said boundary to the Lemno Burn; then northeastward along the said burn to the access road to Bogindollo Farm Cottages; then northwestward along the said road to a point in line with the southern boundary of the field east of Bogindollo Farm Cottages; then northeastward along the said boundary to the unclassified road between Bogindollo and Oathlaw; then northward along the said road to a point in line with the field drain east of Bogindollo; then southeastward along the said drain to the Lemno Burn; then generally northeastward and eastward along the said burn and the River South Esk to the western boundary of ED 3; then generally southward along the said ED boundary to the point of commencement.

Electoral Division 8: Montrose South

Commencing at grid reference NO 7055 4807 on the eastern boundary of Tayside Region, Angus District and ED 4 (Arbroath East); then westward along the said ED boundary to and northwestward along the eastern boundary of ED 3 (Arbroath North and Central Angus) to the River South Esk; then eastward along the said river to grid reference NO 6756 5770 at its confluence in the Montrose Basin, east of the Lurgies; then eastward in a straight line to Mean High Water Springs in Montrose Basin; then generally northeastward, eastward and southward along the said boundary to a point in line with Lower Hall Street, Montrose; then eastward in a straight line to and along the said street to and across Murray Street to Upper Hall Street; then northeastward along the said street to and northwestward along Market Street to Queen Street; then northeastward along the said street to and northeastward along Mill Street to and southeastward along Reform Street and across Mid Links to Eastern Road; then northeastward to and southeastward along Dorward Road across Whinfield Road to Traill Drive; then continuing southeastward in a straight line along Traill Drive and across the North Links Golf Course to grid reference NO 7294 5820 on MLWS at the eastern boundary of Tayside Region and Angus District; then southwestward along the said boundary to the point of commencement.

Electoral Division 9: Montrose North

Commencing at grid reference NO 7294 5820 on the eastern boundary of Tayside Region, Angus District and ED 8 (Montrose South); then westward along the said ED boundary to a point on the River South Esk in line with the water course in Den of Leuchland; then generally northward following the said water course to the railway line between Brechin and Bridge of Dun; then northwestward along the said railway to its junction with the course of the dismantled railway between Edzell and Bridge of Dun then northwestward along the course of the said railway to the bridge carrying the unclassified road on the eastern perimeter of Brechin between Drumachlie and Mains of Pitforthie; then generally northwestward along the said road past Tillygloom to the B966 road; then northward along the said road to the minor road bounding the southern perimeter of Little Keithock; then generally westward along the said road to the A94 road; then southwestward along the said road to the course of the dismantled railway between Edzell and Bridge of Dun; then generally northward along the course of the said railway to West Water northwest of Inchbare; then generally eastward along the said water to the northern boundary of Tayside Region and Angus District; then generally eastward and southward along the said boundary to the point of commencement.

Electoral Division 10: Kirriemuir and Western Glens

Commencing at grid reference NO 3252 4764 on the western boundary of Angus District and ED 6 (Forfar West); then generally northwestward and eastward along the said district boundary to the northern boundary of the former parish of Cortachy and Clova; then generally southeastward along the said boundary to and continuing southeastward along the southern boundary of the former parish of Lethnot and Navar to the northern boundary of the former parish of Menmuir where it meets the Paphrie Burn; then southwestward along the said burn to where it meets the western boundary of the former parish of Menmuir; then generally southward along the said boundary to the Cruick Water; then generally eastward along the said water to the unclassified road south of Blackhall; then southeastward along the said road to and southwestward along the unclassified road leading to Muir of Montboy to grid reference NO 5472 6205 in line with the western field boundary of the field southwest of the cottages known as Findowrie; then southeastward along the said boundary in a straight line to Willie Mills Burn; then southwestward along the said burn to a point in line with the field boundary and western boundary of the woodland area southwest of Findowrie; then southeastward along this boundary and its prolongation in a straight line to the unclassified road between Careston and Barrelwell; then northeastward along the said road to the minor road at the western boundary of the woodland area west of Barrelwell; then generally southeastward, westward and southeastward along the track to the A94 road; then westward along the said road to a point in line with the field drain flowing into the unnamed burn in Rodgers Den within Black Wood; then generally southward along the said drain and burn to the River South Esk and the northern boundary of ED 3 (Arbroath North and Central Angus); then generally southwestward along the northern boundaries of EDs 3, 7 (Forfar East) and 6 to the point of commencement.

Electoral Division 11: Brechin and Eastern Glens

Commencing at grid reference NO 5552 5875 on the northern boundary of ED 3 (Arbroath North and Central Angus) and the eastern boundary of ED 10 (Kirriemuir and Western Glens); then generally northwestward along the said boundary of ED 10 to the northern boundary of Angus District; then generally eastward and southward along the said district boundary to the northern boundary of ED 9 (Montrose North); then westward and southward along the boundary of the said ED to the northern boundary of ED 8 (Montrose South); then westward along the said ED boundary to and along the northern boundary of ED 3 to the point of commencement.

Electoral Division 12: Central

Commencing at grid reference NO 3921 2923 on MLWS, east of the Tay Rail Bridge, on the southern boundary of Tayside Region and the City of Dundee District at a point in line with the subway under the railway between Riverside Drive and Riverside Approach; then northwestward in a straight line across Riverside Drive to and along the subway to and generally northwestward along Riverside Approach to Magdalen Yard Road; then northwestward along Magdalen Yard Road to and continuing northward and westward along Shepherds Loan to and across Perth Road to Hawkhill; then northeastward along Hawkhill to and northwestward along Peddie Street, Blackness Road and Glenagnes Road to a point in line with the northwestern curtilage of the Harris Academy School Annexe opposite No 2A, Glenagnes Road; then northeastward along the said curtilage to a point in line with the western curtilage of the property, No 44, Milnbank Road; then northward in a straight line from the said point and along the said curtilage to Milnbank Road; then northwestward along Milnbank Road and City Road to and southeastward along Tullideph Road and Lochee Road to Dudhope Terrace; then generally northeastward along Dudhope Terrace to a point in line with the western boundary of Dudhope Park; then southeastward along the said boundary and its prolongation to Lochee Road; then generally eastward along Lochee Road to and along the northern section of Marketgait and the inner ring road of the City to East Dock Street; then southwestward along East Dock Street to and southeastward along West Victoria Dock Road and its prolongation in a straight line across Marine Parade to MLWS at grid reference NO 4088 3017, east of the Tay Road Bridge,

on the southern boundary of Tayside Region and the City of Dundee District; then southwestward along the said boundary to the point of commencement.

Electoral Division 13: Riverside

Commencing at grid reference NO 3635 2842 on MLWS southwest of Dundee Airport on the southern boundary of Tayside Region and the City of Dundee District at a point in line with the Invergowrie Burn where it flows under the bridge carrying the main line railway between Dundee and Perth; then northwestward from the said point in a straight line to and continuing northwestward along the said burn to a point in line with the eastern curtilage of No 2, Burnside Road, Invergowrie; then northward along the said curtilage in a straight line to Burnside Road; then generally northward and westward to Main Street; then northeastward along said road to and southeastward along Riverside Avenue to Perth Road; then generally eastward and northeastward along Perth Road and Ninewells Avenue to Glamis Road; then southward along Glamis Road to the western access road to Balgay Cemetery; then northeastward along the said access road to and continuing northeastward along the northern boundary of Balgay Cemetery and the northern and eastern boundary of Balgay Hill to Pentland Avenue; then northeastward along Pentland Avenue to the western boundary of ED 12 (Central); then generally southeastward along the said ED boundary to and westward along the boundary of Tayside Region and the City of Dundee District to the point of commencement.

Electoral Division 14: Lochee

Commencing at grid reference NO 3854 3073 on the western boundary of ED 12 (Central) and the northern boundary of ED 13 (Riverside); then generally westward along the northern boundary of ED 13 to the northern access road to Balgay Hill at the southwestern perimeter of Lochee Park; then north and northeastward along the said access road and Glamis Road to and northwestward along Charleston Drive to Elmwood Road; then northwestward along Elmwood Road to and eastward along South Road to Perrie Street; then northward along Perrie Street to and continuing northward across Liff Road to and northeastward along Quarry Side to Coupar Angus Road; then northwestward along Coupar Angus Road to a point in line with northern curtilage of property at No 47, Coupar Angus Road; then northeastward to and along the said curtilage and continuing generally northeastward along the boundary of properties at Lansdowne Gardens to Kilspindie Road; then southeastward along Kilspindie Road and continuing southeastward by footpath to a point west of Balshando Place and in line with the western curtilage of the housing development north of Lundie Avenue; then northward along the said curtilage to and southeastward along the northern curtilage of the said development and continuing southeastward across Kings Cross Road to the path adjacent to the southwestern boundary of Harp Football Ground; then southeastward along the said path to and southwestward along the said path beside the railway to Harefield Road then southeastward along Harefield Road to Balfield Road; then southward along Balfield Road to and across Loons Road and continuing generally eastward to and along Gardner Street to Rankine Street; then southeastward along Rankine Street to Law Steps path between the properties Nos 18 and 20, Rankine Street; then southwestward along Law Steps path to Lochee Road; then southeastward along Lochee Road to the northern boundary of ED 12; then westward and southward along the said ED boundary to the point of commencement.

Electoral Division 15: Law

Commencing at grid reference NO 3865 3089 on the northern boundary of ED 12 (Central) and the eastern boundary of ED 14 (Lochee); then generally northward along the said boundary of ED 14 to and northeastward along Strathmore Avenue to Strathmartine Road; then southeastward along Strathmartine Road to and continuing southeastward along Hilltown to the tunnel carrying the north eastern section of the inner ring road of the City on the northern boundary of ED 12; then generally westward along the said ED boundary to the point of commencement.

Electoral Division 16: Dens
