ROAD TRAFFIC

The Road Traffic (Special Parking Area) (City of Westminster) Order 1994

Made - - - - 6th June 1994
Laid before Parliament 13th June 1994
Coming into force - - 4th July 1994

Whereas the council of the City of Westminster has applied to the Secretary of State for an order to be made under section 76 of the Road Traffic Act 1991(1) and the Secretary of State has consulted the Commissioner of Police of the Metropolis in accordance with section 76(2) of that Act:

NOW, the Secretary of State for Transport, in exercise of the powers conferred by section 76(1) and section 77(6) of the Road Traffic Act 1991 and of all other powers enabling him in that behalf, hereby makes the following Order:—

Citation and commencement

1. This Order may be cited as the Road Traffic (Special Parking Area) (City of Westminster) Order 1994 and shall come into force on 4th July 1994.

Interpretation

2. In this Order—

"the 1984 Act" means the Road Traffic Regulation Act 1984(2);

"the 1991 Act" means the Road Traffic Act 1991;

a reference in the Schedule to a number followed by the letter "m" is a reference to that number of metres; and

where a road referred to in the Schedule to this Order ("the main road") is joined by another road ("the side road"), whether or not that other road is referred to in the Schedule, and the footway to the main road runs on either side of the mouth of the side road, the junction between

the two roads shall be taken to be an imaginary line drawn across the mouth of the side road between the respective ends of the back line of the footway to the main road on each side.

Designation of special parking area

- **3.**—(1) The Secretary of State hereby designates the City of Westminster as a special parking area except—
 - (a) the roads named or described in Part I and Part II of the Schedule to this Order; and
 - (b) St James's Park, Green Park, Hyde Park, and those parts of Kensington Gardens and Regent's Park which lie within the City of Westminster.
- (2) A reference in the following provisions of this Order to the special parking area is a reference to the area designated by this article.

Modification of the Road Traffic Regulation Act 1984

- **4.**—(1) Section 55 of the 1984 Act (financial provisions relating to designation orders) shall have effect in relation to the City of Westminster as if—
 - (a) at the end of subsection (1) there were inserted the words "and of the income from additional parking charges (within the meaning of section 74(8) of the Road Traffic Act 1991) received by them in respect of vehicles found within the special parking area and the expenditure incurred by them in the discharge of functions exercisable by them in relation to the special parking area by virtue of Part II of the Road Traffic Act 1991"; and
 - (b) after subsection (1) there were inserted the following subsection:
 - "(1A) In subsection (1) above, references to "the special parking area" are to the area designated as a special parking area by the Road Traffic (Special Parking Area) (City of Westminster) Order 1994."
- (2) Section 102(2) of the 1984 Act (charges for removal, storage and disposal of vehicles) shall have effect in relation to a vehicle found in the special parking area as if, in paragraph (d), for the words "a parking place" to the end there were substituted—
 - "(i) a parking place designated under section 6, 9 or 45 of this Act or otherwise provided or controlled by that authority, or
 - (ii) a place where the vehicle was stationary in circumstances in which an offence would have been committed in respect of the vehicle but for section 76(3) of the Road Traffic Act 1991, as they may require."

Modification of the Road Traffic Act 1991

- **5.**—(1) Section 70 of the 1991 Act (exemptions from provisions relating to the immobilisation of vehicles in parking places) shall have effect in relation to a vehicle found in the special parking area as if, in subsections (1) and (2), after the words "section 69(1)" there were inserted the words "or section 77(4)".
- (2) Section 71 of the 1991 Act (representations in relation to removal or immobilisation of vehicles) shall have effect in relation to a vehicle found in the special parking area as if, for subsection (4), there were substituted the following subsection:—
 - "(4) The grounds are—
 - (a) that there were no reasonable grounds for the parking attendant concerned to believe that either—
 - (i) the vehicle had been permitted to remain at rest in the parking place in circumstances specified in section 66(2)(a), (b) or (c) of this Act, or

- (ii) the vehicle had been permitted to remain at rest in a special parking area (other than in a designated parking place) in circumstances in which an offence would have been committed in respect of the vehicle but for section 76(3) of this Act;
- (b) that the vehicle had been permitted to remain at rest in the place in question by a person who was in control of the vehicle without the consent of the owner;
- (c) that the place at which the vehicle was at rest was neither a designated parking place nor in a special parking area;
- (d) in a case within subsection (1)(d) above, that, by virtue of an exemption given by section 70 of this Act, neither section 69 nor 77(4) of this Act applied to the vehicle at the time in question; or
- (e) that the penalty or other charge in question exceeded the amount applicable in the circumstances of the case."
- (3) Section 74(8) of the 1991 Act (fixing of certain parking and other changes for London) shall have effect in relation to the City of Westminster as if, after the words "section 69", there were inserted the words "or section 77(4)".
- (4) Section 79(2) of the 1991 Act(application to Crown and visiting forces) shall have effect in relation to a vehicle found in the special parking area as if, for "66 and 69 to 71", there were substituted "66, 69 to 71, 76 and 77".
- (5) Schedule 6 to the 1991 Act (parking penalties) shall have effect in relation to a vehicle found in the special parking area as if—
 - (a) in sub-paragraph (c) of paragraph 2(4), for the words "the parking place" there were substituted the words "the place in question", and
 - (b) in sub-paragraph (d) of paragraph 2(4), the word "designation" were omitted.

ROADS IN THE CITY OF WESTMINSTER EXCLUDED FROM THE SPECIAL PARKING AREA

- 1. A4 between the borough boundary with the Royal borough of Kensington and Chelsea, north west and north side, together with the south side from its junction with William Street and its junction with Hyde Park Corner including—
 - (a) Brompton Road;
 - (b) Duke of Wellington Place;
 - (c) Grosvenor Place from its junction with Hyde Park Corner to the south east side of its junction with Duke of Wellington Place;
 - (d) Hyde Park Corner;
 - (e) Knightsbridge;
 - (f) Piccadilly from its junction with Hyde Park Corner to the north east side of Duke of Wellington Place; and
 - A315 on the south side from its junction with Knightsbridge (A4) and Brompton Road (A4) and a point 46m east of a point opposite the party wall of 147 to 151 and 153 to 159 Knightsbridge.
- **2.** A5 from the north west side of its junction with St John's Wood Road (A5205) to its junction with Marble Arch (A40).
- **3.** A40 intersection at Marble Arch from the west side of its junction with Bayswater Road (A40) to the east side of its junction with Oxford Street (A40) including—
 - (a) Cumberland Gate; and
 - (b) Park Lane from its junction with Oxford Street to the south east side of its junction with Cumberland Gate.
- **4.** A41 between the borough boundary with the London borough of Camden and its junction with Marylebone Road (A501) including—
 - (a) Baker Street from its junction with Park Road to its junction with Marylebone Road (A501);
 - (b) Dorset Square (east side only);
 - (c) Gloucester Place from its junction with Park Road to the north side of its junction with Dorset Square;
 - (d) Gloucester Place from the south side of its junction with Dorset Square to its junction with Marylebone Road (A501); and
 - (e) Park Road.
- **5.** A202 between the borough boundary with the London borough of Lambeth and its junction with Victoria Street (A302) including—
 - (a) Neathouse Place; and
 - (b) Wilton Road from its junction with Victoria Street (A302) to the south east side of its junction with Neathouse Place.

- **6.** A302 from its junction with Grosvenor Place and Duke of Wellington Place (A4) to the east side of its junction with Bressenden Place (A3217).
- 7. A501 from its junction with Westway (A40(M)) to its junction with Cleveland Street including—
 - (a) the unnamed service road parallel to Marylebone Road from the west side of the Royal Academy of Music to the east side of Harley House;
 - (b) the island that contains Great Portland Street station, the west, south and east sides;
 - (c) Cleveland Street (west side);

and from its junction with Edgware Road (A5) to its junction with Marylebone Road (A501).

- **8.** A3123 from its junction with Vauxhall Bridge Road (A202) to its junction with Eaton Square (A3217) including—
 - (a) Bessborough Street; and
 - (b) Drummond Gate.
- **9.** A3212 from its junction with Chelsea Bridge Road to its junction with Bessborough Gardens and Vauxhall Bridge (A202).
- **10.** A3217 from the south west junction with Eccleston Street (A3123) to its junction with Victoria Street (A302).
- 11. A4202 (both sections) from its junctions with Cumberland Gate (A40) to its junction with Hyde Park Corner (A4) including—
 - (a) Achilles Way;
 - (b) Brook Gate;
 - (c) Curzon Gate:
 - (d) Grosvenor Gate; and
 - (e) Stanhope Gate from its junction with Park Lane (western section) to its junction with Park Lane (eastern section).
- **12.** A5205 from its junction with Maida Vale (A5) to its junction with Wellington Road and Park Road (A41).
- **13.** Allington Street from the south side of its junction with Allington Street to its junction with Victoria Street (A302).
- **14.** Allington Street from the west side of its junction with Allington Street to its junction with Bressenden Place (A3217).
- **15.** Tyburn Way from its junction with Marble Arch (A40) to its junction with Cumberland Gate (A40).

Roads adjacent to A4

- 16. Albert Gate—
 - (a) (west side) between its junction with Knightsbridge (A4) and a point 3.5m north of the north western kerbline of Knightsbridge;
 - (b) (east side) between its junction with Knightsbridge (A4) and a point 3.3m north of the north western kerbline of Knightsbridge.
- 17. Bowater House—

- (a) (east side vehicle exit) (east side) between its junction with Knightsbridge (A4) and a point 2.2m north west of the north western kerbline of Knightsbridge, to a point at the southern facia pillar of Bowater House.
- **18.** Constitution Hill between its junction with Duke of Wellington Place and a point 50m east of the eastern kerbline of Duke of Wellington Place and a point opposite.

19. Grosvenor Crescent—

- (a) (north side) between its junction with Duke of Wellington Place and a point 19m south west of the western kerbline of Grosvenor Place;
- (b) (south side) between its junction with Duke of Wellington Place and a point 15m south west of the western kerbline of Grosvenor Place.

20. Hyde Park Hotel—

- (a) (unnamed vehicle entrance) (east side) between its junction with Knightsbridge (A4) and a point 6.2m north west of the north western kerbline of Knightsbridge;
- (b) (unnamed vehicle entrance) (west side) between its junction with Knightsbridge (A4) and a point 3m north west of the north western kerbline of Knightsbridge and extending eastwards for a distance of 8m, to include the northern section of a single Taxi Rank.

21. Hyde Park House—

- (a) (east side vehicle exit) (east side) between its junction with Knightsbridge (A4) and a point 2.5m north of the north western kerbline of Knightsbridge;
- (b) (east side vehicle exit) (west side) between its junction with Knightsbridge (A4) and a point 2.7m north of the north western kerbline of Knightsbridge;
- (c) (west side vehicle entrance) (east side) between its junction with Knightsbridge (A4) and a point 3.2m north of the north western kerbline of Knightsbridge;
- (d) (west side vehicle entrance) (west side) between its junction with Knightsbridge (A4) and a point 3.4m north of the north western kerbline of Knightsbridge.

22. Knightsbridge Green—

- (a) (west side) between its northern junction with Brompton Road (A4) and a point 2.6m north west of the extended kerbline of Brompton Road and at a point opposite, on the northern end of the island situated at this juncture;
- (b) (west side) between its southern junction with Brompton Road (A4) and a point 3.8m north west of the extended kerbline of Brompton Road and at a point opposite, on the southern end of the island situated at this juncture.

23. Lancelot Place—

- (a) (north east side) between its junction with Brompton Road (A4) and a point 5.7m north west of the extended kerbline of Brompton Road;
- (b) (south west side) between its junction with Brompton Road (A4) and a point 3.4m north west of the extended kerbline of Brompton Road.

24. Montpelier Street—

- (a) (north east side) between its junction with Brompton Road (A4) and a point 21.3m north west of the north western extended kerbline of Brompton Road.
- **25.** Old Barrack Yard between its junction with Knightsbridge (A4) and a point 10m south of the south eastern kerbline of Knightsbridge and a point opposite.

26. Piccadilly—

- (a) (westbound slip road) between its junction with Duke of Wellington Place and a point 35m north east of the eastern portal of the Piccadilly underpass and a point opposite;
- (b) (eastbound slip road) between its junction with Duke of Wellington Place and a point 35m north east of the eastern portal of the Piccadilly underpass and a point opposite.
- **27.** William Street (east side) between its junction with Knightsbridge (A4) and the common boundary between 3 and 4 William Street House.

28. Wilton Place—

- (a) (west side) between its junction with Knightsbridge (A4) and a point 14m south of the southern kerbline of Knightsbridge;
- (b) (east side) between its junction with Knightsbridge (A4) and a point 18m south of the southern kerbline of Knightsbridge.

Roads adjacent to A5

29. Aberdeen Place—

- (a) (north side) between its junction with Maida Vale (A5) and a point 25m south west of the south western flank wall of 69-76 (Block 8) Clifton Court;
- (b) (south side) between its junction with Maida Vale (A5) and a point 8m south west of the common boundary between 1/8 Aberdeen Place and 508 Edgware Road.
- **30.** Bell Street between its junction with Edgware Road (A5) and a point 5m north east of the north western kerbline of Edgware Road and a point opposite.

31. Blomfield Road—

- (a) (north side) between its junction with Maida Vale (A5) and a point 34m south west of the south western kerbline of Maida Vale;
- (b) (south side) between its junction with Maida Vale (A5) and a point 17.5m south west of the south eastern kerbline of Maida Vale.

32. Boscobel Street—

- (a) (north side) between its junction with Edgware Road (A5) and a point 15m north east of the north western kerbline of Edgware Road;
- (b) (south side) between its junction with Edgware Road (A5) and a point 10m north east of the north eastern kerbline of Edgware Road.

33. Broadley Street—

- (a) (north side) between its junction with Edgware Road (A5) and a point 28m north east of the north western kerbline of Edgware Road;
- (b) (south side) between its junction with Edgware Road (A5) and a point 10m north east of the north western kerbline of Edgware Road.
- **34.** Bryanston Street between its junction with Edgware Road (A5) and a point 72m west of the north east flank wall of 53 Bryanston Street and a point opposite.

35. Burwood Place—

- (a) (north side) between its junction with Edgware Road (A5) and a point 19m south west of the south western kerbline of Edgware Road;
- (b) (south side) between its junction with Edgware Road (A5) and a point 23m south west of the south eastern kerbline of Edgware Road.

36. Chapel Street—

- (a) (north side) between its junction with Edgware Road (A5) and a point 9m north east of the south western flank wall of 258 to 264 Edgware Road;
- (b) (south side) between its junction with Edgware Road (A5) and the common boundary between 256 Edgware Road and 15/16 Cabbell Street.

37. Church Street—

- (a) (west arm) between its junction with Edgware Road (A5) and a point 25m south west of the south western kerbline of Edgware Road and a point opposite;
- (b) (east arm) between its junction with Edgware Road (A5) and a point 22m south west of the common boundary between 125 and 127 and 382 to 388 Blackwater House and a point opposite.
- **38.** Clarendon Terrace between its junction with Maida Vale (A5) and a point 10m south west of the south eastern kerbline of Maida Vale and a point opposite.

39. Connaught Street—

- (a) (north side) between its junction with Edgware Road (A5) and a point 20m south west of a point opposite the common boundary between 3/5 Connaught Street;
- (b) (south side) between its junction with Edgware Road (A5) and the common boundary between 1 and 3 Connaught Street.

40. Crawford Place—

- (a) (north side) between its junction with Edgware Road (A5) and a point 25m north east of the north western kerbline of Edgware Road;
- (b) (south side) between its junction with Edgware Road (A5) and a point 12m north east of the north western kerbline of Edgware Road.
- **41.** Crompton Street between its junction with Edgware Road (A5) and the north eastern flank wall of 431/433 Edgware Road and a point opposite.

42. Cuthbert Street—

- (a) (north side) between its junction with Edgware Road (A5) and a point 8m south west of the south western kerbline of Edgware Road;
- (b) (south side) between its junction with Edgware Road (A5) and a point 10m south west of the south eastern kerbline of Edgware Road.

43. Frampton Street—

- (a) (north side) between its junction with Edgware Road (A5) and a point 6m north east of the common boundary between 454 Edgware Road and 108/110 Frampton Street;
- (b) (south side) between its junction with Edgware Road (A5) and a point 10m north east of the north western kerbline of Edgware Road.

44. George Street—

- (a) (north side) between its junction with Edgware Road (A5) and the north eastern flank wall of 136/138 George Street;
- (b) (south side) between its junction with Edgware Road (A5) and the north eastern flank wall of 163/169 George Street.

45. Harrow Road—

(a) (north side) between its junction with Edgware Road (A5) and a point 7m north east of a point opposite the eastern flank wall of 41 Harrow Road and a point opposite;

(b) (south side) between its junction with Edgware Road (A5) and a point 28.5m north east of the eastern flank wall of 41 Harrow Road and a point opposite.

46. Harrowby Street—

- (a) (north side) between its junction with Edgware Road (A5) and a point 10m north east of a point opposite the south western flank wall of 132 to 148 Forest Court;
- (b) (south side) between its junction with Edgware Road (A5) and a point 25m north east of the south western flank wall of 132/148 Forest Court.

47. Kendal Street—

- (a) (north side) between its junction with Edgware Road (A5) and the south western flank wall of 1a Kendal Street;
- (b) (south side) between its junction with Edgware Road (A5) and a point 17.5m south west of the south eastern kerbline of Edgware Road.

48. Maida Avenue—

- (a) (north side) between its junction with Edgware Road (A5) and a point opposite the north eastern flank wall of 451 Edgware Road;
- (b) (south side) between its junction with Edgware Road (A5) and a point 2.5m north east of the north eastern flank wall of 451 Edgware Road.

49. Maida Vale—

- (a) (north side) between its junction with the north west side of St John's Wood Road (A5205) and a point 1m south east of the north west flank wall of 1 to 12 Northwick House;
- (b) (south side) between its junction with a point opposite the south west side of St John's Wood Road (A5205) and a point 5.5m south east of the north west flank wall of 1 Clifton Road.

50. Marylebone Road—

- (a) (north arm)—
 - (i) (north side) between its junction with Edgware Road (A5) and a point 45m east of the south western flank wall of 304/306 Edgware Road;
 - (ii) (south side) between its junction with Edgware Road (A5) and a point 40m east of a point opposite the south western flank wall of 304/306 Edgware Road;

(b) (south arm)—

- (i) (north side) between its junction with Edgware Road (A5) and a point 52m north east of the north western kerbline of Edgware Road;
- (ii) (south side) between its junction with Edgware Road (A5) and a point 50m north east of the north eastern kerbline of Edgware Road.
- **51.** Newcastle Place between its junction with Edgware Road (A5) and a point 3m north east of the north eastern flank wall of 5 Newcastle Place and a point opposite.
- **52.** Orchardson Street between its junction with Edgware Road (A5) and a point 10m north east of the north western kerbline of Edgware Road and a point opposite.

53. Praed Street—

- (a) (north side) between its junction with Edgware Road (A5) and a point 50m north east of a point opposite the common boundary between 7 to 11 and 15 to 21 Praed Street;
- (b) (south side) between its junction with Edgware Road (A5) and a point 21.5m north east of the common boundary between 7 to 11 and 15 to 21 Praed Street.

54. Seymour Street—

- (a) (west arm)—
 - (i) (north side) between its junction with Edgware Road (A5) and a point 30m west of the south eastern kerbline of Edgware Road and a point opposite;
- (b) (east arm)—
 - (i) (north side) between its junction with Edgware Road (A5) and the eastern flank wall of 62 Seymour Street;
 - (ii) (south side) between its junction with Edgware Road (A5) and a point 1m east of a point opposite the common boundary between 58 and 60 Seymour Street.
- **55.** Star Street between its junction with Edgware Road (A5) and a point 10m south west of the south western kerbline of Edgware Road and a point opposite.
- **56.** St Michael's Street between its junction with Edgware Road (A5) and a point 10m south west of the south eastern kerbline of Edgware Road and a point opposite.
- **57.** Stourcliffe Street between its junction with Edgware Road (A5) and a point 10m north east of the south eastern kerbline of Edgware Road and a point opposite.

58. Sussex Gardens—

- (a) (north side) between its junction with Edgware Road (A5) and a point 7m north east of the common boundary between 12 to 14 and 16 Sussex Gardens;
- (b) (south side) between its junction with Edgware Road (A5) and a point 29m north east of a point opposite the common boundary between 12 to 14 and 16 Sussex Gardens.

59. Upper Berkeley Street—

- (a) (north side) between its junction with Edgware Road (A5) and a point 47m east of the north western kerbline of Edgware Road;
- (b) (south side) between its junction with Edgware Road (A5) and a point 12m east of the eastern flank wall of 42/43 Hampden Gurney Street.

Roads adjacent to A40

60. Bayswater Road between its junction with Cumberland Gate and a point 42m east of the eastern kerbline of Stanhope Place and a point opposite.

61. Great Cumberland Place—

- (a) (west side) between its junction with Marble Arch and a point 23m north of the north western kerbline of Marble Arch;
- (b) (east side) between its junction with Marble Arch and a point 15m north of the north eastern kerbline of Marble Arch.

62. North Carriage Drive—

- (a) (north side) between its junction with Cumberland Gate and the eastern flank wall of Cumberland Lodge;
- (b) (south side) between its junction with Cumberland Gate and a point 30m east of the eastern flank wall of Cumberland Lodge.

63. Oxford Street—

(a) (north side) between its junction with Marble Arch and a point 3m west of the western kerbline of Old Quebec Street;

(b) (south side) between its junction with Marble Arch and a point 5m west of a point opposite the western kerbline of Old Quebec Street.

Roads adjacent to A41

64. Acacia Road—

- (a) (north side) between its junction with Finchley Road and Wellington Road (A41) and a point 9m south west of the north western flank wall of St John's Wood;
- (b) (south side) between its junction with Finchley Road and Wellington Road (A41) and a point 10m north east of the south western boundary of Birley Lodge.
- **65.** Allsop Place between its junction with Park Road and Baker Street (A41) and a point 2m south east of the north western flank wall of 1 Cornwall Terrace Mews and a point opposite.
- **66.** Alpha Close between its junction with Park Road (A41) and a point 10m south west of the south western kerbline of Park Road and a point opposite.

67. Boundary Road—

- (a) (west arm-south side) between its junction with Finchley Road (A41) and a point 18m west of the south western kerbline of Finchley Road and a point opposite;
- (b) (east arm-south side) between its junction with Finchley Road (A41) and a point 25m east of the north eastern kerbline of Finchley Road.

68. Circus Road—

- (a) (west arm) between its junction with Wellington Road (A41) and a point 17m south west of the north eastern flank wall of the Humana Hospital and a point opposite;
- (b) (east arm) between its junction with Wellington Road (A41) and a point 6m south west of the common boundary between 26 and 28 Circus Road and a point opposite.
- **69.** Dorset Close between its junction with Gloucester Place (A41) and a point 10m south west of the western kerbline of Gloucester Place and a point opposite.

70. Dorset Square—

- (a) (north arm) between its junction with Gloucester Place (A41) and a point 12m south west of the western kerbline of Gloucester Place and a point opposite;
- (b) (south arm) between its junction with Gloucester Place (A41) and a point 22m south west of the western kerbline of Gloucester Place and a point opposite.
- **71.** Finchley Place between its junction with Finchley Road (A41) and a point 15m south west of the south western kerbline of Finchley Road and a point opposite.

72. Grove End Road—

- (a) (north side) between its junction with Finchley Road and Wellington Road (A41) and a point 7m south west of the north eastern flank wall of Eyre Court;
- (b) (south side) between its junction with Finchley Road and Wellington Road (A41) and a point 10.5m north east of the south western flank wall of 71-84 Wellington Court.

73. Grove Gardens—

- (a) (north side) between its junction with Park Road (A41) and a point 8m south west of the north eastern wall of 129 Park Road;
- (b) (south side) between its junction with Park Road (A41) and a point 2.5m south west of the north eastern wall of 125 Park Road.
