**1.** This Order may be cited as the Football Spectators (Seating) Order 1994 and shall come into force on 15th July 1994.

This Order directs the Football Licensing Authority to include in any licence to admit spectators (defined in section 1(7) of the Football Spectators Act 1989 ("the Act")) to Wembley Stadium, the National Stadium in Cardiff ("Cardiff Arms Park") or the football grounds, all in England, also listed in Schedule 1, a condition imposing requirements specified in Schedule 2 as respects the seating of spectators at designated football matches at those premises. "Designated football matches" are those association football matches designated by the Secretary of State, under powers conferred by section 1(2) of the Act, in the Football Spectators (Designation of Football Matches in England and Wales) Order 1993 (S.I.1993/1691) and they include all association football matches played at the premises listed in Schedule 1 to this Order.
