The Potato Marketing Scheme (Amendment) Order 1994

Made - - - - 7 September 1994 Coming into force - - 8 September 1994

Whereas the Potato Marketing Board duly submitted to the Minister of Agriculture, Fisheries and Food, the Secretary of State concerned with agriculture in Scotland and the Secretary of State for Wales (hereinafter called "the Ministers") certain amendments of the Potato Marketing Scheme(1), in accordance with sub-paragraphs (1) to (3) of paragraph 1 of the First Schedule to the Agricultural Marketing Act 1958(2) (hereinafter called "the 1958 Act");

And whereas the Ministers caused notice of those amendments to be published in accordance with section 2(1) of the 1958 Act as applied to amendments by paragraph 1(4) of the First Schedule thereto;

And whereas the Ministers proposed to modify those amendments;

And whereas the Ministers gave notice of their proposed modifications to the Potato Marketing Board;

And whereas the Potato Marketing Board, within four weeks after that notice had been so given, notified the Ministers that they assented to those modifications;

And whereas the Ministers are satisfied that those amendments as so modified will conduce to the more efficient operation of the Potato Marketing Scheme;

And whereas those amendments as so modified are set out in the Schedule hereto;

Now, therefore, the Ministers, acting jointly in exercise of the powers conferred by section 2 of, and Schedule 1 to, the 1958 Act, and now vested in them(3), hereby make the following Order:

- 1. This Order may be cited as the Potato Marketing Scheme (Amendment) Order 1994.
- **2.** The amendments of the Potato Marketing Scheme which are set out in the Schedule hereto are hereby approved and shall come into force on 8 September 1994.

SCHEDULE Article 2

The Potato Marketing Scheme shall be further amended to give effect, in each provision of that Scheme mentioned in the first column of Part A below, to each proposed amendment specified opposite that provision in the second column of that Part below, and to replace Schedule A to that Scheme by the Schedule in Part B below:

11(1), (2) and (3)	Delete sub-paragraphs (1), (2) and (3) from the current paragraph and replace them by:— "(1) An election of all district members shall be held for all districts on such day before the first retirement date as may be fixed by the Board and on such day in the month of September or October in every fourth year thereafter as may be fixed by the Board. (2) Subject to the provisions of this Scheme, members so elected shall hold office for four years from the 31st October next following their election, except that the members who are

	"(b) members so elected shall hold office from the 31st October next following their election until the 31st October in the first subsequent year in which there is an election of all district members."
12	Delete the existing paragraph.
13(2)	Delete "or of a special member, as the case may be," and "of a special member for Scotland or".
13(5) and (6)	Delete these sub-paragraphs.
13(7) to (11)	Renumber existing sub-paragraphs (7) to (11) as sub-paragraphs (5) to (9).
13(12) and (13)	Delete these sub-paragraphs.
13(14) to (18)	Renumber sub-paragraphs (14) to (18) as sub-paragraphs (10) to (14) and in sub-paragraph (18) delete "(17)" and replace it by "(13)" and delete "(8)" and replace it by "(6)".
14(1)	Delete "or special member or members" and replace it by "member".
14(4)	Delete paragraphs (b) and (c) and re-letter paragraph (d) as paragraph (b).
16(1) opening paragraph	Delete "or special" and "or territory".
16(1) proviso	Delete "or territory".

SCHEDULE A

DISTRICT MEMBERS OF THE BOARD

Subject to paragraph 10 there shall be thirteen districts bearing respectively the names set out in the first column of the following table; each district shall consist of the areas specified opposite thereto in the second column of that table; save as otherwise specified in that table each such area shall be geographically identical to the equivalent area included in the table before the amendment of this Scheme approved by the Potato Marketing Scheme (Amendment) Order 1994, the equivalent area being the area identically named in that table before that amendment; and the Soke of Peterborough shall be as referred to in the Local Government Act 1933(4).

EXPLANATORY NOTE

(This note is not part of the Order)

This Order reduces the total size of the Potato Marketing Board from 23 members to 16 members. The number, and the boundaries of, the Board's electoral districts are altered and the number of district members is reduced from 18 to 13. There will no longer be a special member for Scotland and a special member for England and Wales. These changes in the composition of the Board will take effect from such day in the month of September or October next following the coming into force of this Order as the Board shall fix ("the first retirement date"). There will be an election of all new district members before the first retirement date and thereafter an election of all district members in every fourth subsequent year. Other minor and consequential amendments to the Potato Marketing Scheme are made.
