The Road Traffic (Special Parking Areas) (London Borough of Wandsworth) (Amendment) Order 1994

Whereas the council of the London borough of Wandsworth has applied to the Secretary of State for an order to be made under section 76 of the Road Traffic Act 1991⁽¹⁾ and the Secretary of State has consulted the Commissioner of Police of the Metropolis in accordance with section 76(2) of that Act: NOW, the Secretary of State for Transport, in exercise of the powers conferred by section 76(1) and section 77(6) of the Road Traffic Act 1991 and of all other powers enabling him in that behalf, hereby makes the following Order:—

Citation and commencement

1. This Order may be cited as the Road Traffic (Special Parking Areas)(London Borough of Wandsworth) (Amendment) Order 1994 and shall come into force on 28th November 1994.

Interpretation

2. In this Order “the principal order” means the Road Traffic (Special Parking Areas) (The London Borough of Wandsworth) Order 1993⁽²⁾.

Amendment of the principal order

3.—(1) The principal order shall be amended as follows.

(2) In article 2 the definitions of “centre line” and “carriageway” shall be omitted.

(3) Article 2 as so amended shall become paragraph (1) of article 2 and, after that paragraph, there shall be inserted the following paragraphs:

“(2) Where a road referred to in the Schedule to this Order (“the main road”) is joined by another road (“the side road”), whether or not that other road is referred to in the Schedule,

and the footway to the main road runs on either side of the mouth of the side road, the junction between the two roads shall be taken to be an imaginary line drawn across the mouth of the side road between the respective ends of the back line of the footway to the main road on each side.

(3) A reference in the Schedule to this Order to a number followed by the letter “m” is a reference to that number of metres.”

(4) Article 3 shall be omitted.

(5) For article 4 there shall be substituted:

“4.—(1) The Secretary of State hereby designates the London borough of Wandsworth except—

(a) the roads named or described in the Schedule to this Order; and

(b) that part of Richmond Park which lies within the London borough of Wandsworth, as a special parking area.

(2) A reference in the following provisions of this Order to the special parking area is a reference to the area designated by this article.”

(6) For the words “an area” in article 5(1)(b), there shall be substituted “the area”.

(7) For the words “a special parking area” in article 5(2) and article 6(1), article 6(2) (in the first place where those words occur) and article 6(4) and (5) there shall in each case be substituted “the special parking area”.

(8) For Schedules 1, 2 and 3, there shall be substituted the Schedule contained in the Schedule to this Order.

 - (c) A205 Clapham Common West Side between its junction with Battersea Rise and Clapham Common North Side (A3) and its junction with The Avenue (A205).
4. A214 between its junction with Huguenot Place and Wandsworth Common North Side (A3) and the borough boundary with the London borough of Lambeth.
5. A217 between its junctions with Putney Bridge Road (A3209) and Wandsworth High Street (A3) and its junction with York Road (A3205) including—
 - (a) Armoury Way; and
 - (b) Ram Street.
6. A306 between its junction with Upper Richmond Road (A205) and its junction with Kingston Road (A3).
7. A3205 between its junction with Swandon Way (A217) and the borough boundary with the London borough of Lambeth.
8. A3220 between the borough boundary with the Royal borough of Kensington and Chelsea and its junction with Clapham Common North Side (A3).

 - (a) (north side) between its junction with Northcote Road and a point 18m west of the western kerbline of Northcote Road;
 - (b) (south side) between its junction with Northcote Road and a point 7m west of the western kerbline of Northcote Road.
10. Acris Street—
 - (a) (north east side) between its junction with Huguenot Place (A3) and a point 13m north west of the south eastern flank wall of 4 Huguenot Place;
 - (b) (south west side) between its junction with Huguenot Place (A3) and a point 4m north west of the north western flank wall of 2 Acris Street.

18. Auckland Road between its junction with Battersea Rise (A3) and a point 5m north west of the north western boundary wall of 1 Auckland Road.
19. Barchard Street (north side) between its junction with Fairfield Street (A3) and a point 5m east of the eastern flank wall of 6 Barchard Street.
20. Bartholomew Close between its junction with East Hill (A3) and a point 2m south east of the north western flank wall of 50 East Hill.
21. Beaumont Road between its junction with West Hill (A3) and a point 4.5m north west of the front boundary of 173 and 175 Beaumont Road.
22. Bolingbroke Grove—
 - (a) (north arm) between its junction with Battersea Rise (A3) and a point 55m north west of the north western kerblines of Battersea Rise;
 - (b) (south arm) between its junction with Battersea Rise (A3) and a point 57m south east of the south eastern kerblines of Battersea Rise.
23. Boutflower Road between its junction with Battersea Rise (A3) and an imaginary straight line drawn between a point on the north side at the front boundary of 2 and 3 Boutflower Road and a point opposite.
24. Bowood Road between its junction with Clapham Common West Side (A3) and a point 8m north of the northern boundary wall of 2 Bowood Road.
25. Broomhill Road between its junction with West Hill (A3) and a point 41.5m south east of the south eastern kerblines of West Hill.
26. Buckhold Road—
 - (a) (south east side) between its junction with Wandsworth High Street (A3) and a point 63m south west of the south western kerblines of Wandsworth High Street;
 - (b) (north west side) between its junction with Wandsworth High Street (A3) and the north western kerblines of Hardwick's Way.

27. Buckmaster Road between its junction with Battersea Rise (A3) and a point 2.5m north west of the north western boundary wall of 1 Buckmaster Road.

28. Canford Road between its junction with Clapham Common West Side (A3) and a point 10m north west of the north western boundary wall of 1 Canford Road.

29. Carter's Yard between its junction with Wandsworth High Street (A3) and a point 20m north west of the north western kerblines of Wandsworth High Street.

30. Chesterton Close (south side) between its junction with Putney Bridge Road and a point 6m west of the western kerblines of Putney Bridge Road.

31. Chivalry Road—

- (a) (north east side) between its junction with Battersea Rise (A3) and the northern boundary wall of 1 Chivalry Road;
- (b) (north west side) between its junction with Battersea Rise (A3) and a point 50m south east of the south eastern kerblines of Battersea Rise.

32. Clapham Common West Side—

- (a) (east side) between its junction with The Avenue (A205) and a point 8m south of the front boundary of 98 and 99 Clapham Common West Side;
- (b) (west side) between its junction with The Avenue (A205) and the front boundary of 94 and 95 Clapham Common West Side.

33. Cromford Road between its junction with West Hill (A3) and a point 1m north of the southern boundary wall of 1 Cromford Road.

34. Dempster Road between its junction with East Hill (A3) and the rear boundary of 74 East Hill.

35. Dormay Street between its junction with Armoury Way (A3) and a point 10.5m north of the northern kerblines of Armoury Way.

36. Dromore Road between its junction with West Hill (A3) and a point 20m north west of the north western kerblines of West Hill.

37. Eccles Road between its junction with Battersea Rise (A3) and a point 5m south east of the south eastern boundary wall of 57 Eccles Road.

38. Elsynges Road—

- (a) (north side) between its junction with Marcilly Road and a point 10m west of the western boundary wall of 54 Elsynges Road;
- (b) (south side) between its junction with Marcilly Road and a point 1m east of the common boundary of 55 and 57 Elsynges Road.

39. Fairfield Drive—

- (a) (north arm) between its junction with Fairfield Street (A3) and a point 11.5m north east of the north eastern kerblines of Fairfield Street;
- (b) (south arm) between its junction with Fairfield Street (A3) and a point 10m north east of the north eastern kerblines of Fairfield Street.

40. Forthbridge Road between its junction with Clapham Common North Side (A3) and a point 19m south of the southern boundary wall of 78 Forthbridge Road.

41. Friars Avenue—

- (a) (south west arm) between its junction with Stag Lane and a point 4m north east of the common boundary of 8 and 10 Friars Avenue;

- (b) (north east arm) between its junction with Stag Lane and an imaginary straight line drawn between a point on the north west side 20m north east of the north eastern kerbline of Stag Lane and a point opposite.

- 43.** Garratt Lane—
 - (a) (east side) between its junction with Wandsworth High Street (A3) and the northern kerbline of the first access road;
 - (b) (west side) between its junction with Wandsworth High Street (A3) and a point 17m south of the northern flank wall of the post office, Garratt Lane.
- 44.** Geraldine Road between its junction with East Hill (A3) and a point 11m north west of the north western boundary wall of 2 Geraldine Road.
- 45.** Grandison Road between its junction with Clapham Common West Side (A3) and a point 5.5m north east of the common boundary of 3 and 5 Grandison Road.
- 46.** Hafer Road between its junction with Battersea Rise (A3) and a point 1m south of the southern flank wall of 2 Hafer Road.
- 47.** Haldon Road between its junction with West Hill (A3) and the common boundary of 2d and 2e Haldon Road.
- 48.** Herndon Road between its junction with East Hill (A3) and a point 5m north west of the north western boundary wall of 1 Herndon Road.
- 49.** Jedburgh Street between its junction with Clapham Common North Side (A3) and a point 26m south of the front boundary of 51 and 53 Jedburgh Street.
- 50.** Keswick Road between its junction with West Hill (A3) and a point 15m north west of the north western kerbline of West Hill.
- 51.** Lavender Gardens between its junction with Clapham Common North Side (A3) and a point 15.5m north of the northern kerbline of Clapham Common North Side.
- 52.** Lavender Sweep—
 - (a) (north side) between its junction with Battersea Rise (A3) and the common boundary of 139 and 141 Lavender Sweep;
 - (b) (south side) between its junction with Battersea Rise (A3) and a point opposite the common boundary of 141 and 143 Lavender Sweep.
- 53.** Lavender Walk between its junction with Battersea Rise (A3) and a point 10m north of the northern kerbline of Battersea Rise.
- 54.** Leathwaite Road between its junction with Battersea Rise (A3) and a point 1m north east of the front boundary of 3 and 5 Leathwaite Road.
- 55.** Lebanon Road—
 - (a) (east side) between its junction with West Hill (A3) and a point 3m south east of the front boundary of 4 and 5 Lebanon Road;
 - (b) (west side) between its junction with West Hill (A3) and the south eastern boundary wall of the fire station.
- 56.** Limburg Road between its junction with Battersea Rise (A3) and a point 4m south of the front boundary of 2 and 4 Limburg Road.

57. Lindore Road between its junction with Battersea Rise (A3) and a point 15m north of the northern boundary wall of 1 Lindore Road.

58. Lytton Grove between its junction with West Hill (A3) and a point 10m south east of the south eastern flank wall of 53 Lytton Grove.

59. Marcilly Road.

60. Marjorie Grove between its junction with Clapham Common North Side (A3) and a point 20m north of the northern kerblines of Clapham Common North Side.

61. Marney Road between its junction with Clapham Common North Side (A3) and a point 20m south of the southern flank wall of 107 Marney Road.

62. Melody Road—

(a) (north east side) between its junction with Huguenot Place (A3) and a point 11m north west of the front boundary of 1 and 3 Melody Road;

(b) (south east side) between its junction with Huguenot Place (A3) and a point 3.5m north west of the north western flank wall of 2 Melody Road.

63. Merton Road—

(a) (north west side) between its junction with West Hill (A3) and the north eastern flank wall of 2 Merton Road;

(b) (south east side) between its junction with West Hill (A3) and a point 2m north east of the common boundary of 4 and 5 Downbury Mews.

64. Muncaster Road between its junction with Clapham Common West Side (A3) and a point 10m north west of the north western boundary wall of 1 Muncaster Road.

65. Norstead Place—

(a) (north west side) between a point 6.5m north east of the south western boundary of Chohole Gate Lodge and a point 22m south west of the south western flank wall of Chohole Gate Lodge;

(b) (south east side) between a point 7.5m north east of the south western boundary wall of Chohole Gate Lodge and a point 20m south west of the south western flank wall of Chohole Gate Lodge.

66. Northcote Road between its junction with Battersea Rise (A3) and the north west flank wall of 11 Northcote Road.

67. Portinscale Road between its junction with West Hill (A3) and the common boundary wall of 3 Portinscale Road and 102 West Hill.

68. Putney Bridge Road—

(a) (east side) between its junction with Wandsworth High Street (A3) and a point 14m north of the northern boundary wall of 30 Putney Bridge Road;

(b) (west side) between its junction with Wandsworth High Street (A3) and the southern kerblines of Chesterton Close.

69. Putney Heath Lane between its junction with West Hill (A3) and an imaginary straight line drawn between a point on the south west side 19m south west of the north western kerblines of West Hill and a point opposite.

70. Ringford Road between its junction with West Hill (A3) and a point 18m north west of the north western boundary wall of 1 Ringford Road.

71. Santos Road between its junction with West Hill (A3) and a point 24m south of the southern boundary wall of 1 Santos Road.

78. St. John's Road between its junction with Battersea Rise (A3) and an imaginary straight line drawn between a point on the north east side at the front boundary of 73 and 75 St. John's Road and a point opposite.

79. Stormont Road—

- (a) (east side) between its junction with Clapham Common North Side (A3) and a point 19m north of the northern kerblines of Clapham Common North Side;
- (b) (west side) between its junction with Clapham Common North Side (A3) and a point 18m north of the northern kerblines of Clapham Common North Side.

80. Sugden Road between its junction with Clapham Common North Side (A3) and the southern boundary of 133 Sugden Road.

81. Sutherland Grove between its junction with West Hill (A3) and a point 30m south east of the south eastern kerblines of West Hill.

82. Taybridge Road between its junction with Clapham Common North Side (A3) and a point 30m south of the front boundary of 161 and 163 Taybridge Road.

83. Tibbet's Ride between its junction with Kingston Road (A3) and a point 280m north of the northern kerblines of Kingston Road.

84. Tonsley Hill between its junction with East Hill (A3) and a point 3m south east of the south eastern flank wall of 2 Tonsley Hill.

85. Tonsley Place between its junction with Fairfield Street (A3) and a point 15m east of the eastern kerbline of Fairfield Street.

86. Tregarvon Road between its junction with Clapham Common North Side (A3) and a point 25m south of the common boundary of 51 and 53 Tregarvon Road.

87. Wandsworth Common West Side between its junction with Huguenot Place (A3) and a point 60m south east of the south eastern kerbline of Huguenot Place.

88. Wandsworth Plain.

89. Webb's Road between its junction with Battersea Rise (A3) and the southern boundary of 39 Battersea Rise.

90. West Hill Road between its junction with West Hill (A3) and a point 4m south east of the north western boundary of 1 West Hill Road.

91. Wimbledon Park Side between its junction with the north west kerbline of the central reserve of Tibbet's Corner Roundabout and a point 52m south east of the south east kerbline of the central reserve of Tibbet's Corner Roundabout.

92. Wixs Lane (east side) between its junction with Clapham Common North Side (A3) and a point 8.5m north of the northern kerbline of Clapham Common North Side.

93. Woodwell Street.

94. Alderbrook Road between its junction with Balham Hill (A24) and a point 4m east of the eastern flank wall of 134 Alderbrook Road.

95. Aldis Street between its junction with Tooting High Street (A24) and a point 9m south east of the common boundary of 2 and 4 Aldis Street.

96. Ansell Road between its junction with Upper Tooting Road (A24) and a point 20m north west of the north western kerbline of Upper Tooting Road.

97. Balham Grove between its junction with Balham High Road (A24) and a point 26m north west of the north western kerbline of Balham High Road.

98. Balham New Road—

(a) (north side) between its junction with Balham High Road (A24) and a point 6m west of the front boundary of 37 and 37b Balham High Road;

(b) (south side) between its junction with Balham High Road (A24) and a point 24m east of the eastern kerbline of Balham High Road.

99. Balham Park Road between its junction with Balham High Road (A24) and a point 23m north west of the north western kerbline of Balham High Road.

100. Balham Station Road between its junction with Balham High Road (A24) and the north west flank wall of 1 Balham Station Road.

101. Bedford Hill—

(a) (north east side) between its junction with Balham High Road (A24) and the south eastern flank wall of 13 Bedford Hill;

(b) (south west side) between its junction with Balham High Road (A24) and the front boundary of 8 and 10 Bedford Hill.

102. Beechcroft Road between its junction with Upper Tooting Road (A24) and the front boundary of 2 and 4 Beechcroft Road.

- (a) (north west side) between its junction with Battersea Bridge Road (A3220) and the eastern boundary of 13 Parkgate Road;

323. Petworth Street between its junction with Battersea Bridge Road (A3220) and the common boundary of 2 and 3 Petworth Street.

324. Prince of Wales Drive between its junction with Albert Bridge Road (A3220) and the western kerblines of Soudan Road.

325. Rosenau Crescent—

- (a) between its junction with Prince of Wales Drive (A3220) and a point 10m south of the southern kerblines of Prince of Wales Drive;
- (b) between its junction with Battersea Bridge Road (A3220) and the common boundary of 14 and 16 Rosenau Crescent.

326. Rosenau Road between its junction with Prince of Wales Drive (A3220) and a point 10m north of the northern kerblines of Prince of Wales Drive.

327. Sabine Road between its junction with Latchmere Road (A3220) and the boundary wall of 131 Latchmere Road and 1 Eversleigh Road.

328. Sheepcote Lane between its junction with Latchmere Road (A3220) and a point 20m east of the north eastern kerblines of Latchmere Road.

329. Shellwood Road between its junction with Latchmere Road (A3220) and a point 2m north east of the south western boundary wall of 25 Poyntz Road.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Road Traffic (Special Parking Areas) (The London Borough of Wandsworth) Order 1993 (“the principal order”) so as to designate the whole of the London borough of Wandsworth (excluding the roads named or described in the Schedule and the part of Richmond Park in the borough) as a special parking area for the purposes of Part II of the Road Traffic Act 1991 with effect from 28th November 1994. The new area subsumes the two special parking areas designated by the principal order.
