**The Merchant Shipping (Salvage and Pollution)
Act 1994 (Commencement No. 2) Order 1994**

The Secretary of State for Transport, in exercise of the powers conferred on him by section 10(4) of the Merchant Shipping (Salvage and Pollution) Act 1994(1), hereby makes the following Order:—

1. This Order may be cited as the Merchant Shipping (Salvage and Pollution) Act 1994 (Commencement No. 2) Order 1994.

2. The provisions of the Merchant Shipping (Salvage and Pollution) Act 1994 specified in the first column of the Schedule to this Order (which relate to the matters specified in the second column of that Schedule) shall come into force on 1st January 1995.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order brings into force on 1st January 1995 further provisions of the Merchant Shipping (Salvage and Pollution) Act 1994.

In particular it brings into force provisions giving the Salvage Convention, 1989, the force of law in the United Kingdom together with consequential provisions. (The Convention, although ratified by the United Kingdom, is not yet in force internationally). The Order also makes possible the implementation of the International Convention on Oil Pollution Preparedness, Response and Co-operation, 1990, and of provisions of the United Nations Convention on the Law of the Sea 1982, relating to the protection and preservation of the marine environment from pollution by ships.
