# SHERIFF COURT, SCOTLAND

Act of Sederunt (Fees of Sheriff Officers) (No.2) 1994

Made - - - - 16th December 1994
Laid before Parliament 20th December 1994
Coming into force - 9th January 1995

The Lords of Council and Session, under and by virtue of the powers conferred on them by section 40 of the Sheriff Courts (Scotland) Act 1907(1), section 6 of the Execution of Diligence (Scotland) Act 1926(2) and of all other powers enabling them in that behalf, do hereby enact and declare:

#### Citation and commencement

- 1.—(1) This Act of Sederunt may be cited as the Act of Sederunt (Fees of Sheriff Officers) (No.2) 1994 and shall come into force on 9th January 1995.
  - (2) This Act of Sederunt shall be inserted in the Books of Sederunt.

#### Amendment of fees

- 2.—(1) Subject to the provisions of the following sub-paragraphs, for the Table of Fees in Schedule 1 to the Act of Sederunt (Fees of Sheriff Officers) 1994(3), substitute the Table of Fees in the Schedule to this Act of Sederunt.
- (2) The Table of Fees in Schedule 1 to the Act of Sederunt (Fees of Sheriff Officers) 1994 as substituted by sub-paragraph (1) above shall apply to work done on or after the date on which this Act of Sederunt comes into force.
- (3) The Table of Fees in Schedule 1 to the Act of Sederunt (Fees of Sheriff Officers) 1994 having effect before the substitution under sub-paragraph (1) above shall continue to have effect in respect of work done before the date on which this Act of Sederunt comes into force.
