The Legal Advice and Assistance at Police Stations (Remuneration) (Amendment) Regulations 1995

The Lord Chancellor, in exercise of the powers conferred on him by sections 34 and 43 of the Legal Aid Act 1988(1), having had regard to the matters specified in section 34(9) and having consulted the General Council of the Bar and the Law Society and with the consent of the Treasury, hereby makes the following Regulations:—

Citation and commencement

1. These Regulations may be cited as the Legal Advice and Assistance at Police Stations (Remuneration) (Amendment) Regulations 1995 and shall come into force on 24th April 1995.

Transitional provisions

2. These Regulations shall apply for the purposes of work done on or after 24th April 1995 to which the Legal Advice and Assistance at Police Stations (Remuneration) Regulations 1989(**2**) apply.

Amendments to the Legal Advice and Assistance at Police Stations (Remuneration) Regulations 1989

3. The Schedule to these Regulations shall be substituted for the Schedule to the Legal Advice and Assistance at Police Stations (Remuneration) Regulations 1989.

1.—(1) The Board shall, subject to paragraphs 2 and 3, allow fees for work allowed by it under regulation 5 at the following rates:

2. The fee allowed under paragraph 1(1)(a) shall be reduced by the amount of any other fees allowed under that paragraph for work done as a duty solicitor during that duty period to a maximum of one half of the fee allowed under paragraph 1(1)(a).

3. In the case of a franchisee, the Board shall allow fees for work allowed by it under regulation 5 at the following rates:

These Regulations amend the Legal Advice and Assistance at Police Stations (Remuneration) Regulations 1989. They increase the rates of remuneration for work done on or after 24th April 1995, and introduce higher rates for franchisees.
