# The Road Traffic (Special Parking Area) (London Borough of Newham) (Amendment) Order 1996

Made - - - - 16th April 1996
Laid before Parliament 25th April 1996

Whereas the council of the London borough of Newham has applied to the Secretary of State for Transport for an order to be made under section 76 of the Road Traffic Act 1991(1) and the Secretary of State has consulted the Commissioner of Police of the Metropolis in accordance with section 76(2) of that Act:

NOW, the Secretary of State for Transport, in exercise of the powers conferred by section 76(1) and section 77(6) of the Road Traffic Act 1991 and of all other powers enabling him in that behalf, hereby makes the following Order:—

#### Citation and commencement

1. This Order may be cited as the Road Traffic (Special Parking Area) (London Borough of Newham) (Amendment) Order 1996 and shall come into force on 20th May 1996.

#### Amendment of the Road Traffic (Special Parking Area) (London Borough of Newham) Order 1994

**2.** The amendments to the Schedule to the Road Traffic (Special Parking Area) (London Borough of Newham) Order 1994(**2**) set out in the Schedule to this Order shall have effect.

# AMENDMENTS TO THE SCHEDULE TO THE ROAD TRAFFIC (SPECIAL PARKING AREA) (LONDON BOROUGH OF NEWHAM) ORDER 1994

- 1. For paragraphs 5 to 22 there shall be substituted—
  - "5. Abbey Lane between its junction with High Street, Stratford (A11) and a point 37 metres south east of the south eastern kerbline of High Street.
    - 6. Angel Lane—
      - (a) (east side) between its junction with Great Eastern Road (A11) and a point 79 metres north of the northern kerbline of Great Eastern Road;
      - (b) (west side) between its junction with Great Eastern Road (A11) and a point 81 metres north of the northern kerbline of Great Eastern Road.
  - 7. Bisson Road between its junction with Abbey Lane and a point 13 metres south east of the southern kerbline of Abbey Lane.
  - **8.** Blaker Road between its junction with High Street, Stratford (A11) and a point 13 metres north of the north eastern kerbline of High Street.
  - **9.** Bow Street between its junction with Leytonstone Road (A11) and a point 15 metres east of the eastern kerbline of Leytonstone Road.
  - **10.** Bridge Road between its junction with High Street, Stratford (A11) and a point 47 metres south east of the south eastern kerbline of High Street.
  - **10A.** Bridge Terrace between its junction with Bridge Road and a point 5 metres north east of the north eastern kerbline of Bridge Road.
  - 11. Broadway (north western arm—north west side) between its junction with The Grove (A11) and a point 3 metres south west of the party wall of 132-134 Broadway, Stratford.
  - **12.** Burford Road between its junction with High Street, Stratford (A11) and a point 35 metres south east of the south eastern kerbline of High Street.
  - **13.** Buxton Road between its junction with Leytonstone Road (A11) and a point 25 metres east of the eastern kerbline of Leytonstone Road.

#### 14. Cam Road—

- (a) (east side) between its junction with High Street, Stratford (A11) and a point 24 metres south east of the south eastern kerbline of High Street;
- (b) (west side) between its junction with High Street, Stratford (A11) and a point 20 metres south east of the south eastern kerbline of High Street.
- **15.** Carpenters Road between its junction with High Street, Stratford (A11) and a point 70 metres north west of the north western kerbline of High Street.
  - **16.** Chant Street (north western arm).
- 17. Cherry Tree Road between its junction with Leytonstone Road (A11) and a point 24 metres west of the western kerbline of Leytonstone Road.
- **18.** Chobham Road between its junction with Leytonstone Road (A11) and the easternmost boundary of 2 Chobham Road.
- **19.** Cooks Road between its junction with High Street, Stratford (A11) and a point 12 metres north west of the north western kerbline of High Street.

- **20.** Deason Street between its junction with High Street, Stratford (A11) and a point 12 metres south east of the south eastern kerbline of High Street.
- **21.** Forest Lane between its junction with Leytonstone Road (A11) and a point 44 metres east of the north eastern kerbline of Leytonstone Road.
- **22.** Francis Street between its junction with Leytonstone Road (A11) and a point 44 metres north west of the north western kerbline of Leytonstone Road."
- **2.** Paragraph 23 shall be omitted.
- **3.** For paragraphs 24 to 31 there shall be substituted—
  - "24. Grove Crescent Road—
    - (a) (northern arm) between its junction with Great Eastern Road (A11) and a point 17 metres north of the northern kerbline of Great Eastern Road;
    - (b) (southern arm)
      - (i) (east side) between its junction with Great Eastern Road (A11) and a point 15 metres south of the southern kerbline of Great Eastern Road;
      - (ii) (west side) between its junction with Great Eastern Road (A11) and a point 26 metres south of the southern kerbline of Great Eastern Road;
    - (c) (easternmost junction with The Grove) between its junction with The Grove (A11) and a point 45 metres west of the western kerbline of The Grove.
  - **25.** Gurney Road between its junction with Leytonstone Road (A11) and the easternmost boundary of 2 Gurney Road.
  - **26.** Henniker Road between its junction with Leytonstone Road (A11) and a point 26 metres west of the western kerbline of Leytonstone Road.
  - **27.** Hunts Lane between its junction with High Street, Stratford (A11) and a point 15 metres south east of the south eastern kerbline of High Street.
  - **28.** Janson Road between its junction with Leytonstone Road (A11) and a point 10 metres east of the south eastern kerbline of Leytonstone Road.
  - **28A.** Jupp Road West between its junction with Carpenters Road and a point 15 metres north east of the north eastern kerbline of Carpenters Road.
  - **29.** Lett Road between its junction with High Street, Stratford (A11) and a point 10 metres north west of the north western kerbline of High Street.
  - **29A.** Livingstone Road between its junction with High Street, Stratford (A11) and a point 25 metres south east of the south eastern kerbline of High Street.
  - **30.** Manbey Grove between its junction with The Grove (A11) and a point 34 metres east of the eastern kerbline of The Grove, measured on the south side.
  - **31.** Manbey Park Road between its junction with The Grove (A11) and a point 21 metres north east of the north eastern kerbline of The Grove."
- 4. Paragraph 32 shall be omitted.
- **5.** For paragraphs 33 to 40 there shall be substituted—
  - "33. Marshgate Lane between its junction with High Street, Stratford (A11) and a point 70 metres north west of the north western kerbline of High Street.
  - **34.** Maryland Road between its junction with Leytonstone Road (A11) and a point 20 metres west of the western kerbline of Leytonstone Road.

- **35.** Maryland Street between its junction with Leytonstone Road (A11) and a point 25 metres west of the western kerbline of Leytonstone Road.
- **36.** Oxford Road between its junction with Great Eastern Road (A11) and a point 17 metres north of the northern kerbline of Great Eastern Road.
- **37.** Romford Road between its junction with The Grove and Broadway (A11) and a point 5 metres west of the westernmost boundary wall of 20 Romford Road.
- **38.** Salway Road between its junction with Great Eastern Road (A11) and a point 11 metres south of the southern kerbline of Great Eastern Road.
  - **39.** Service Route No. 1—
    - (a) (northernmost junction with Great Eastern Road (A11)) between its junction with Great Eastern Road and a point 4 metres south of the southern boundary wall of the public conveniences;
    - (b) (southernmost junction with Great Eastern Road (A11)) between its junction with Great Eastern Road and a point 13 metres north east of the north eastern kerbline of Great Eastern Road.
  - **40.** Service Route No. 2—
    - (a) (easternmost junction with Great Eastern Road (A11)) between its junction with Great Eastern Road and the easternmost boundary of 1 Gerry Raffles Square;
    - (b) (westernmost junction with Great Eastern Road (A11)) between its junction with Great Eastern Road and a point 15 metres south east of the south eastern kerbline of Great Eastern Road, measured on the north east side."
- **6.** Paragraph 41 shall be omitted.
- 7. For paragraphs 42 to 52 there shall be substituted—
  - "42. Station Street—
    - (a) (northernmost junction)
      - (i) (north west side) between its junction with Great Eastern Road (A11) and a point 38 metres south west of the south western kerbline of Great Eastern Road;
      - (ii) (south east side) between its junction with Great Eastern Road (A11) and a point 22 metres south west of the south western kerbline of Great Eastern Road;
    - (b) (southernmost junction)
      - (i) (north side) between its junction with Great Eastern Road (A11) and a point 20 metres west of the western kerbline of Great Eastern Road;
      - (ii) (south side) between its junction with Great Eastern Road (A11) and a point 38 metres west of the western kerbline of Great Eastern Road.
  - **43.** Sugar House Lane, between its junction with High Street, Stratford (A11) and a point 12 metres south east of the south eastern kerbline of High Street.
  - **43A.** Tramway Avenue, between its junction with Broadway (A11) and the south eastern boundary wall of 5 West Ham Lane.
  - **44.** Union Street, between its junction with High Street, Stratford (A11) and a point 40 metres south east of the south eastern kerbline of High Street.

- **45.** Ward Road, between its junction with High Street, Stratford (A11) and a point 10 metres north west of the north western kerbline of High Street.
- **46.** Warton Road, between its junction with High Street, Stratford (A11) and a point 40 metres north west of the north western kerbline of High Street.
- **46A.** Water Lane, between its junction with Forest Lane and a point 20 metres south of the southern kerbline of Forest Lane.
- **47.** Well Street, between its junction with Windmill Lane (A11) and a point 35 metres north west of the north western kerbline of Windmill Lane.
- **48.** West Ham Lane, between its junction with Broadway and a point 10 metres south east of the south eastern kerbline of Broadway.
- **49.** Windmill Lane, between its junction with Leytonstone Road (A11) and a point 24 metres west of the western kerbline of Well Street, measured on the north side.
- **50.** Wingfield Road, between its junction with Leytonstone Road (A11) and the boundary between 4 and 6 Wingfield Road.

#### 51. Wise Road—

- (a) (north east arm) between its junction with High Street, Stratford (A11) and a point 34 metres south east of the south eastern kerbline of High Street;
- (b) (south west arm) between its junction with High Street, Stratford (A11) and a point 37 metres south east of the south eastern kerbline of High Street.
- **52.** Unnamed road (lying to the east of the main carriageway of The Grove (A11)—sometimes known as Grove Gardens)—
  - (a) (northernmost junction) between its junction with The Grove (A11) and a point 25 metres south of the southern wall of 107 The Grove;
  - (b) the carriageway lying between the two island sites which comprise the western boundary of the unnamed road and which lies opposite 91 The Grove;
  - (c) (southernmost junction) between its junction with The Grove (A11) and a point 15 metres north east of the north eastern kerbline of The Grove, measured on the south east side.
- **52A.** Unnamed road (lying to the south east of High Street, Stratford (A11) and fronting Meesons's Wharf)—
  - (a) (north easternmost junction) between its junction with High Street, Stratford (A11) and a point 7 metres south east of the south eastern kerbline of High Street, measured on the north east side;
  - (b) (south westernmost junction) between its junction with High Street, Stratford (A11) and a point 8 metres south east of the south eastern kerbline of High Street.
- **52B.** The carriageway linking the north western arm of Broadway and The Grove (which lies between the island site situated opposite 108–110 to 122 Broadway, Stratford and St. John's Church south west side) between its junction with The Grove (A11) and a point 18 metres north west of the north western kerbline of The Grove."
