**The Nottingham Healthcare National Health Service
Trust (Transfer of Trust Property) (No. 2) Order 1996**

The Secretary of State for Health, in exercise of the powers conferred on him by section 92(1) of the National Health Service Act 1977(1) and of all other powers enabling him in that behalf, having regard to the change in the arrangements for the administration of hospitals and other establishments and facilities formerly managed by the Nottingham Health Authority resulting from the establishment of the Nottingham Healthcare National Health Service Trust(2), having consulted that Trust and the special trustees for Nottingham University Hospitals in accordance with section 92(3) of that Act, hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Nottingham Healthcare National Health Service Trust (Transfer of Trust Property) (No. 2) Order 1996 and shall come into force on 13th August 1996.

(2) In this Order—

“the special trustees” means the special trustees for Nottingham University Hospitals;

“the Trust” means the Nottingham Healthcare National Health Service Trust;

“the trust property” means the items specified in a schedule of trust property prepared by and agreed upon by the special trustees and the Trust on 31st July 1995, which schedule has been signed on behalf of both the special trustees and the Trust.
