**The North Glamorgan National Health Service
Trust (Transfer of Trust Property) Order 1996**

Made - - - - *23rd August 1996*
Laid before Parliament *5th September 1996*
Coming into force - - *1st October 1996*

The Secretary of State for Wales, in exercise of the powers conferred on him by section 92(1) of the National Health Service Act 1977(1) and of all other powers enabling him in that behalf, having regard to the change in the arrangements for the administration of hospitals and other establishments and facilities formerly managed by Mid Glamorgan District Health Authority(2) resulting from the establishment of North Glamorgan National Health Service Trust(3), having consulted Bro Taf Health Authority(4) and that Trust in accordance with section 92(3) of that Act, hereby makes the following Order:—

Citation, commencement and interpretation

1.—(1) This Order may be cited as the North Glamorgan National Health Service Trust (Transfer of Trust Property) Order 1996 and shall come into force on 1st October 1996.

(2) In this Order—

“the Authority” means Bro Taf Health Authority;

“the Trust” means North Glamorgan National Health Service Trust;

“the trust property” means the items specified in a schedule of trust property prepared by and agreed upon by the Authority and the Trust on 21st June 1996, which schedule has been signed on behalf of the Authority and the Trust.
