The Secretary of State for Health, in exercise of the powers conferred on him by section 92(1) of the National Health Service Act 1977(1) and of all other powers enabling him in that behalf, having regard to the change in the arrangements for the administration of St. Mary's Hospital, Isles of Scilly, formerly managed by the Cornwall Healthcare National Health Service Trust and now managed by the Plymouth Community Services National Health Service Trust, having consulted those Trusts in accordance with section 92(3) of that Act, hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Plymouth Community Services National Health Service Trust (Transfer of Trust Property) Order 1996 and shall come into force on 21st October 1996.

(2) In this Order “the trust property” means the items specified in a schedule of trust property prepared by and agreed upon by the Cornwall Healthcare National Health Service Trust and the Plymouth Community Services National Health Service Trust on 15th July 1996, which schedule has been signed on behalf of both those Trusts.

Transfer of trust property

2. On 21st October 1996 the trust property shall be transferred from the Cornwall Healthcare National Health Service Trust to the Plymouth Community Services National Health Service Trust.
