**The Portsmouth Health Care National Health Service
Trust (Transfer of Trust Property) Order 1997**

The Secretary of State for Health, in exercise of the powers conferred on him by section 92(1) of the National Health Service Act 1977(1) and of all other powers enabling him in that behalf, having regard to the change in the arrangements for the administration of hospitals and other establishments and facilities previously managed by the former Portsmouth and South-East Hampshire Health Authority resulting from the establishment of the Portsmouth Health Care National Health Service Trust(2), having consulted the Portsmouth and South-East Hampshire Health Authority and that Trust in accordance with section 92(3) of that Act, hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Portsmouth Health Care National Health Service Trust (Transfer of Trust Property) Order 1997 and shall come into force on 3rd July 1997.

(2) In this Order—

“the Authority” means the Portsmouth and South-East Hampshire Health Authority, established on 1st April 1996(3);

“the trust” means the Portsmouth Health Care National Health Service Trust;

“the trust property” means the items specified in a Schedule of trust property prepared by and agreed upon by the Authority and the trust on 10th June 1996 which schedule has been signed on behalf of the Authority and the trust.
