# 1997 No. 2824 (S. 177) SHERIFF COURT, SCOTLAND

Act of Sederunt (Fees of Sheriff Officers) 1997

Made - - - - 21st November 1997

Laid before Parliament 28th November 1997

Coming into force - - 1st January 1998

The Lords of Council and Session, under and by virtue of the powers conferred on them by section 40 of the Sheriff Courts (Scotland) Act 1907(1) section 6 of the Execution of Diligence (Scotland) Act 1926(2) and of all other powers enabling them in that behalf, do hereby enact and declare:

#### Citation and commencement

- 1.—(1) This Act of Sederunt may be cited as the Act of Sederunt (Fees of Sheriff Officers) 1997 and shall come into force on 1st January 1998.
  - (2) This Act of Sederunt shall be inserted in the Books of Sederunt.

### Amendment of fees

- 2.—(1) Subject to sub-paragraph (2) below, the Table of Fees in the Schedule to this Act of Sederunt shall be substituted for the Table in Schedule 1 to the Act of Sederunt (Fees of Sheriff Officers) 1994((3) and shall apply to work carried out by a sheriff officer on or after the date on which this Act of Sederunt comes into force.
- (2) Sub-paragraph (1) above does not affect the fees payable as respects any work so carried out before the date mentioned in that sub-paragraph.
