ROAD TRAFFIC

The Road Traffic (Special Parking Area) (London Borough of Sutton) Order 1998

Made - - - - 27th April 1998
Laid before Parliament 8th May 1998
Coming into force - - 1st June 1998

Whereas the council of the London borough of Sutton has applied to the Secretary of State for an order to be made under section 76 of the Road Traffic Act 1991(1) and the Secretary of State has consulted the Commissioner of Police of the Metropolis in accordance with section 76(2) of that Act:

NOW, the Secretary of State for the Environment, Transport and the Regions, in exercise of the powers conferred by section 76(1) and section 77(6) of the Road Traffic Act 1991 and of all other powers enabling him in that behalf, hereby makes the following Order:—

Citation and commencement

1. This Order may be cited as the Road Traffic (Special Parking Area) (London Borough of Sutton) Order 1998 and shall come into force on 1st June 1998.

Revocation

2. The Orders specified in Schedule 1 to this Order are hereby revoked.

Interpretation

3. In this Order—

"the 1984 Act" means the Road Traffic Regulation Act 1984(2);

"the 1991 Act" means the Road Traffic Act 1991;

"the special parking area" means the area designated as a special parking area by article 4 of this Order;

a reference in Schedule 2 to this Order to a number followed by the letter "m" is a reference to that number of metres; and

where a road referred to in Schedule 2 to this Order ("the main road") is joined by another road ("the side road"), whether or not that other road is referred to in that Schedule, and the footway to the main road runs on either side of the mouth of the side road, the junction between the two roads shall be taken to be an imaginary line drawn across the mouth of the side road between the respective ends of the back line of the footway to the main road on each side.

Designation of special parking area

4. The Secretary of State hereby designates as a special parking area the London borough of Sutton except the roads named or described in Schedule 2 to this Order.

Modification of the Road Traffic Regulation Act 1984

- **5.**—(1) Section 55 of the 1984 Act (financial provisions relating to designation orders) shall have effect in relation to the London borough of Sutton as if—
 - (a) at the end of subsection (1) there were inserted the words "and of the income from additional parking charges (within the meaning of section 74(8) of the Road Traffic Act 1991) received by them in respect of vehicles found within the special parking area and the expenditure incurred by them in the discharge of functions exercisable by them in relation to the special parking area by virtue of Part II of the Road Traffic Act 1991"; and
 - (b) after subsection (1) there were inserted the following subsection—
 - "(1A) In subsection (1) above, references to "the special parking area" are to the area designated as a special parking area by the Road Traffic (Special Parking Area) (London Borough of Sutton) Order 1998."
- (2) Section 102(2) of the 1984 Act (charges for removal, storage and disposal of vehicles) shall have effect in relation to a vehicle found in the special parking area as if, in paragraph (d), for the words "a parking place" to the end there were substituted—
 - "(i) a parking place designated under section 6, 9 or 45 of this Act or otherwise provided or controlled by that authority, or
 - (ii) a place where the vehicle was stationary in circumstances in which an offence would have been committed in respect of the vehicle but for section 76(3) of the Road Traffic Act 1991,

as they may require."

Modification of the Road Traffic Act 1991

- **6.**—(1) Section 70 of the 1991 Act (exemptions from provisions relating to the immobilisation of vehicles in parking places) shall have effect in relation to a vehicle found in the special parking area as if, in subsections (1) and (2), after the words "section 69(1)" there were inserted the words "or section 77(4)".
- (2) Section 71 of the 1991 Act (representations in relation to removal or immobilisation of vehicles) shall have effect in relation to a vehicle found in the special parking area as if, for subsection (4), there were substituted the following subsection—
 - "(4) The grounds are—
 - (a) that there were no reasonable grounds for the parking attendant concerned to believe that either—

- (i) the vehicle had been permitted to remain at rest in the parking place in circumstances specified in section 66(2)(a), (b) or (c) of this Act, or
- (ii) the vehicle had been permitted to remain at rest in a special parking area (other than in a designated parking place) in circumstances in which an offence would have been committed in respect of the vehicle but for section 76(3) of this Act;
- (b) that the vehicle had been permitted to remain at rest in the place in question by a person who was in control of the vehicle without the consent of the owner;
- (c) that the place at which the vehicle was at rest was neither a designated parking place nor in a special parking area;
- (d) in a case within subsection (1)(d) above, that, by virtue of an exemption given by section 70 of this Act, neither section 69 nor 77(4) of this Act applied to the vehicle at the time in question; or
- (e) that the penalty or other charge in question exceeded the amount applicable in the circumstances of the case."
- (3) Section 74(8) of the 1991 Act (fixing of certain parking and other charges for London) shall have effect in relation to the London borough of Sutton as if, after the words "section 69", there were inserted the words "or section 77(4)".
- (4) Section 79(2) of the 1991 Act (application to Crown and visiting forces) shall have effect in relation to a vehicle found in the special parking area as if, for "66 and 69 to 71", there were substituted "66, 69 to 71, 76 and 77".
- (5) Schedule 6 to the 1991 Act (parking penalties) shall have effect in relation to a vehicle found in the special parking area as if—
 - (a) in sub-paragraph (c) of paragraph 2(4), for the words "the parking place" there were substituted the words "the place in question", and
 - (b) in sub-paragraph (d) of paragraph 2(4), the word "designation" were omitted.

Roads adjacent to A24

- **5.** Burleigh Road between its junction with Stonecot Hill (A24) and a point 5m north west of the north western boundary of 89 Burleigh Road.
- **6.** Cheam Common Road between its junction with London Road (A24) and the common boundary between 25 and 27 Cheam Common Road.
- 7. Church Hill Road between its junction with Malden Road and a point 2m south west of the south western flank wall of 277 Church Hill Road.
- **8.** Clarkes Avenue between its junction with London Road (A24) and a point 1m south east of the north western boundary of 745 London Road.

- **9.** Courtenay Road between its junction with London Road (A24) and a point 5m south east of the common boundary between 1 and 3 Courtenay Road.

- **16.** Kingsbridge Road between its junction with Stonecot Hill (A24) and the common boundary between 4 and 6 Kingsbridge Road.
- 17. Kingsmead Avenue between its junction with London Road (A24) and the common boundary between 2 and 4 Kingsmead Avenue.
- **18.** Langley Avenue between its junction with London Road (A24) and a point 2m south east of the north western flank wall of 2 Langley Avenue.
- **19.** Lavender Avenue between its junction with London Road (A24) and a point 5m south east of the common boundary between 1 and 3 Lavender Avenue.
- **20.** Lloyd Road between its junction with London Road (A24) and a point 5m north west of the south eastern boundary of 1 Lloyd Road.
- **21.** Malden Road between its junction with London Road (A24) and the common boundary between 376 and 378 Malden Road.

- **44.** Collingwood Road between its junction with Oldfields Road (A217) and the common boundary between 306 and 304 Collingwood Road.

- **45.** Cornwall Road between its junction with Belmont Rise (A217) and a point 7m north of the common boundary between 75 and 77 Cornwall Road.
- **46.** Dorset Road between its junction with Belmont Rise (A217) and a point 10m east of the common boundary between 4 and 6 Dorset Road.

47. Gander Green Lane—

- (a) (west arm) between its junction with St Dunstan's Hill (A217) and the common boundary between 307 and 309 Gander Green Lane;
- (b) (east arm) between its junction with St Dunstan's Hill (A217) and a point 5m south of the common boundary between 218 and 220 Gander Green Lane.
- **48.** Glastonbury Road between its junction with Reigate Avenue (A217) and the south eastern boundary of 116 Reigate Avenue.

49. Green Lane—

- (a) (north east arm) between its junction with Rose Hill Roundabout (A217) and a point opposite the common boundary between 26—30 and 31—35 Cheshire House;
- (b) (south west arm) between its junction with Rose Hill Roundabout (A217) and a point 2m south east of the common boundary between 26—30 and 31—35 Cheshire House.
- **50.** Lumley Road between its junction with St Dunstan's Hill (A217) and a point 3m south east of the common boundary between 42 and 44 Lumley Road.
- **51.** Lymbourne Close between its junction with Belmont Rise (A217) and a point 10m east of that junction.

- **93.** Hallowell Avenue (south side) between its junction with Bridges Lane and a point 3m west of the western kerbline of Bridges Lane.
- **94.** Harcourt Road between its junction with Croydon Road (A232) and a point 38m northwest of the north western boundary of 34 Harcourt Road.
- **95.** Harrow Road between its junction with Carshalton Road (A232) and a point 10m northeast of the north eastern boundary of 78 to 80 Harrow Road.

- **96.** Highfield Road between its junction with Carshalton Road (A232) and the southwestern flank wall of 5 to 6 Brindley House, Highfield Road.
 - **97.** High Street, Sutton—

- **119.** Rectory Lane between its junction with Croydon Road (A232) and a point 30m north of the southern boundary of 227 Croydon Road.
- **120.** Revel Road between its junction with Cheam Road (A232) and a point 25m southeast of the common boundary between 1 and 3 Revel Road.
- **121.** Ringstead Road between its junction with Carshalton Road (A232) and a point 16m south of the southern boundary of 1 Ringstead Road.
- **122.** Roberts Close between its junction with Ewell Road (A232) and a point 10m northwest of the extended line of the northeastern kerbline of Ewell Road.
- **123.** Roseberry Road between its junction with Cheam Road (A232) and a point 38m north of the northern boundary of 1 Roseberry Road.

124. Rotherfield Road—

- (a) (west side) between its junction with High Street, Carshalton (A232) and a point opposite a point 18m northwest of the common boundary between 3 and 5 Rotherfield Road;
- (b) (east side) between its junction with High Street, Carshalton (A232) and a point 30m northwest of the common boundary between 1 and 3 Rotherfield Road.
- **125.** St Barnabas Road between its junction with Carshalton Road (A232) and the common boundary between 1 and 3 St Barnabas Road.

126. St James Road—

- (a) (north arm) between its junction with Cheam Road (A232) and a point 27m southeast of the southern boundary of 27 St James Road;
- (b) (southern arm) (i) (west side) between its junction with Cheam Road (A232) and a point 33m north of the northern boundary wall of 23a St James Road; (ii) (east side) between its junction with Cheam Road (A232) and a point opposite a point 32m north of the northern boundary wall of 23a St James Road.

127. St Nicholas Way—

- (a) (east side) between its junction with Cheam Road (A232) and a point opposite a point 10m southeast of the northwestern rear wall of the Civic Centre, St Nicholas Way;
- (b) (west side) between its junction with Cheam Road (A232) and a point 3m southeast of its junction with Gibson Road.
- **128.** Salcott Road between its junction with Croydon Road (A232) and a point 38m south of the northern boundary of 102 Croydon Road.

129. Sandhills between its junction with Croydon Road (A232) and a point 4m east of the common boundary between 1 and 3 Sandhills.

130. Sherwood Park Road—

- (a) (west side) between its junction with Cheam Road (A232) and a point opposite a point 7m south of the common boundary between 2 and 4 Sherwood Park Road;
- (b) (east side) between its junction with Cheam Road (A232) and a point 9m south of the common boundary between 2 and 4 Sherwood Park Road.
- **131.** Shorts Road between its junction with Carshalton Road (A232) and a point 35m south of the southern boundary of 1 Shorts Road.

132. Station Way—

- (a) (west side) between its junction with Ewell Road (A232) and a point 21m south of the common boundary between 16 and Century House, Station Way;
- (b) (east side) between its junction with High Street, Cheam (A232) and a point 7m north of the common boundary between 15 to 19 and 21 Station Way.
- **133.** Streeters Lane between its junction with Croydon Road (A232) and a point 68m south of the north western boundary wall of Sherwood Park School, Streeters Lane.

134. Summerville Gardens—

- (a) (west arm) between its junction with Cheam Road (A232) and a point 33m north of the southern boundary of 183 Cheam Road;
- (b) (east arm) between its junction with Cheam Road (A232) and a point 34m north of the northern boundary of 1 Summerville Gardens.
- **135.** Sutton Grove between its junction with Carshalton Road (A232) and a point 40m south of the southern flank wall of 13 to 24 Relko Gardens, Sutton Grove.
 - **136.** The Broadway, Beddington.
- **137.** The Broadway, Cheam between its junction with Ewell Road (A232) and the common boundary between 21 and 23 The Broadway.
- **138.** The Holt between its junction with Croydon Road (A232) and a point 20m northwest of the south eastern boundary of 1 The Holt.
- **139.** The Manor Way between its junction with Croydon Road (A232) and a point 41m northwest of the north western boundary of 2 The Manor Way.
- **140.** The Square between its junction with High Street, Carshalton (A232) and a point 20m southeast of the extended line of the north western front wall of 14 High Street, Carshalton.
- **141.** Throwley Way between its junction with Carshalton Road (A232) and a point 19m south of the southern kerbline of Throwley Road.
- **142.** Victoria Road between its junction with Carshalton Road (A232) and a point 2m northwest of the party wall between 2a and 2b Victoria Road.
- **143.** Wallace Crescent between its junction with Pound Street (A232) and a point 2m northwest of the southern boundary of 61 Pound Street.
- **144.** Weihurst Gardens between its junction with Carshalton Road (A232) and a point 15m north of the southern boundary of 280 Carshalton Road.
- **145.** Westcroft Road between its junction with High Street, Carshalton (A232) and a point 3m northeast of the north eastern flank wall of `Westcroft', Westcroft Road.

- **146.** Western Road between its junction with Cheam Road (A232) and a point 27m south of the common boundary between 1 and 1a Western Road.
- **147.** West Street between its junction with Pound Street (A232) and a point 49m south east of the south eastern boundary of the 'Old Rectory', West Street.
- **148.** Willoughby Avenue between its junction with Croydon Road (A232) and a point 38m north of the southern boundary of 71 Croydon Road.
 - 149. Wilmot Road—
 - (a) (north side) between its junction with Pound Street (A232) and a point 11m southeast of the south eastern boundary wall of 91 Pound Street.
 - (b) (south side) between its junction with Pound Street (A232) and a point opposite a point 4m southeast of the southeastern boundary wall of 91 Pound Street.
- **150.** Wright's Row (north side) between its junction with Manor Road and a point 5m west of the extended kerbline of Manor Road.
- **151.** York Road between its junction with Cheam Road (A232) and a point 52m north of the northern boundary of 2 Derby Road.

This Order revokes and consolidates the Road Traffic (Special Parking Area) (London Borough of Sutton) Order 1994 and the Orders amending it, by continuing the designation of the London borough of Sutton, excluding the roads listed in Schedule 2, as a special parking area.
