The Non-Domestic Rating Contributions (Wales) (Amendment) Regulations 1998

Made - - - - 25th November 1998
Laid before Parliament 7th December 1998
Coming into force - - 31st December 1998

The Secretary of State for Wales, in exercise of the powers conferred on him by sections 140(4), 143(1) and (2) of, and paragraphs 4, 5 and 6 of Schedule 8 to the Local Government Finance Act 1988(1), and of all other powers enabling him in that behalf, hereby makes the following Regulations:

Citation, commencement and interpretation

- 1.—(1) These Regulations may be cited as the Non-Domestic Rating Contributions (Wales) (Amendment) Regulations 1998 and shall come into force on 31st December 1998.
- (2) In these Regulations "the 1992 Regulations" means the Non-Domestic Rating Contributions (Wales) Regulations 1992(2).

Amendment of the 1992 Regulations

- **2.** In relation to financial years beginning on or after 1st April 1999, Schedules 2 and 4 to the 1992 Regulations are amended as follows:—
 - (a) in paragraph 2(12) of Schedule 2 to the 1992 Regulations, for "0.996" there shall be substituted "0.999";
 - (b) in paragraph 8(1) of that Schedule, for "1.1 per cent" there shall be substituted "1.2 per cent";
 - (c) for Schedule 4 to the 1992 Regulations there shall be substituted the Schedule set out in the Schedule to these Regulations.
