ROAD TRAFFIC

The A41 Trunk Road (Camden) (Temporary Prohibition of Traffic) Order 1998

Made - - - - 20th February 1998 Coming into force - - 24th February 1998

The Traffic Director for London, in accordance with a direction given to him by the Secretary of State under section 58(1) of the Road Traffic Act 1991(1) and in exercise of the powers conferred on the Secretary of State by section 14 of the Road Traffic Regulation Act 1984(2), and of all other enabling powers, hereby makes the following Order:—

- 1. This Order may be cited as the A41 Trunk Road (Camden) (Temporary Prohibition of Traffic) Order 1998, and shall come into force on 24th February 1998.
- **2.** This Order is made because the Traffic Director for London is satisfied that traffic on the roads, or lengths of road, mentioned in the schedule to this Order should be prohibited because works are being or are proposed to be executed on or near those roads or lengths of road.
- **3.** During the period starting at 00.01 hours on 25th February 1998 for a period of six months, or when those works have been completed, whichever is the sooner, no person shall cause or permit any vehicle to stop at any time in the roads, or lengths of roads, specified in the schedule to this Order.
- **4.**—(1) The prohibitions specified in article 3 above shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs specified by regulations or authorised under section 64 of the Road Traffic Regulation Act 1984.
 - (2) The prohibitions specified in article 3 above shall not apply in respect of—
 - (i) any vehicle being used for the purpose of those works, or for fire brigade, ambulance or police purposes, or
 - (ii) anything done with the permission or at the direction of a police constable in uniform or a traffic warden.
- 5. In so far as, and during such times as, the prohibition specified in article 3 above is in force, the provisions of the A41 Trunk Road (Camden) Red Route Experimental (No.2) Traffic Order 1997(3)
