### The Social Security (Miscellaneous Amendments) (No. 2) Regulations 1998

The Secretary of State for Social Security, in exercise of powers conferred upon her by sections 64(1), 68(4)(c), 70(4), 71(6), 146A, 147(1), (4) and (5) of the Social Security Contributions and Benefits Act 1992(1), sections 10(1), (5)(a) and (b) and (7) and 26(1) to (3) of the Child Support Act 1995(2), paragraph 7A of Schedule 2 to the Abolition of Domestic Rates (Scotland) Act 1987(3), section 146(6) of, and paragraph 6 of Schedule 4 to, the Local Government Finance Act 1988(4), sections 24 and 30 of the Criminal Justice Act 1991(5) and section 116(1) of, and paragraphs 1 and 6 of Schedule 4 and paragraph 6 of Schedule 8 to, the Local Government Finance Act 1992(6) and of all other powers enabling her in that behalf, and after agreement by the Social Security Advisory Committee that these Regulations should not be referred to it(7), hereby makes the following Regulations:

Paragraph 7A of Schedule 2 to the 1987 Act as continued in effect by virtue of that Order, was amended by paragraph 10 of Schedule 2 to the Jobseekers Act 1995 (c. 18).
  - (4) 1988 c. 41 (“the 1988 Act”); section 146(6) is cited because of the meaning given to the word “prescribed”. Paragraph 6 of Schedule 4 was repealed by Schedule 14 to the Local Government Finance Act 1992 (c. 14), but continues to have effect for the purposes of amending the Community Charges (Deductions from Income Support) (No. 2) Regulations 1990 (S.I. 1990/545) by virtue of Article 2 of the Local Government Finance Act 1992 (Recovery of Community Charge) Saving Order 1993 (S.I. 1993/1780). Paragraph 6 of Schedule 4 to the 1988 Act as continued in effect by virtue of that Order, was amended by paragraph 18 of Schedule 2 to the Jobseekers Act 1995.
  - (5) 1991 c. 53.
  - (6) 1992 c. 14; paragraph 6 of Schedule 4 and paragraph 6 of Schedule 8 were amended by the Jobseekers Act 1995, Schedule 2, paragraphs 75 and 76 respectively. Section 116(1) is an interpretation provision and is cited because of the meaning given to the word “prescribed”.
  - (7) See sections 170 and 173(1)(b) of the Social Security Administration Act 1992 (c. 5); paragraph 20 of Schedule 3 to the Child Support Act 1995 (c. 34) added that Act to the list of “relevant enactments” in respect of which regulations must normally be referred to the Committee.

### **Citation and commencement**

1. These Regulations may be cited as the Social Security (Miscellaneous Amendments) (No. 2) Regulations 1998 and shall come into force on 20th March 1998.

### **Amendment of the Social Security (Miscellaneous Amendments) Regulations 1998**

2. In regulation 1(1) of the Social Security (Miscellaneous Amendments) Regulations 1998<sup>(8)</sup> for the words “and regulation 16” there shall be substituted the words “and regulations 2, 3, 16, 18(2) (a) and (d) to (g) and 18(1) in so far as it relates those sub-paragraphs”.

## EXPLANATORY NOTE

*(This note is not part of the Regulation)*

These Regulations amend the Social Security (Miscellaneous Amendments) Regulations 1998 ([S.I. 1998/563](#)) by inserting a commencement date for regulations 2, 3 and 18 which was omitted from those Regulations.
