The East Yorkshire Hospitals and the Royal Hull Hospitals National Health Service Trusts (Dissolution) Order 1999

Made - - - - 24th September 1999

Coming into force - - 1st October 1999

The Secretary of State for Health, in exercise of the powers conferred on him by section 126(3) of the National Health Service Act 1977(1) and section 5(1) of the National Health Service and Community Care Act 1990(2) and of all other powers enabling him in that behalf, on the application of the East Yorkshire Hospitals National Health Service Trust and the Royal Hull Hospitals National Health Service Trust(3), and after completion of the consultation prescribed under paragraph 29(3) of Schedule 2 to the latter Act(4), hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the East Yorkshire Hospitals and the Royal Hull Hospitals National Health Service Trusts (Dissolution) Order 1999 and shall come into force on 1st October 1999.

Dissolution of NHS trusts

2. The East Yorkshire Hospitals National Health Service Trust established by the East Yorkshire Hospitals National Health Service Trust Establishment Order(**5**) and the Royal Hull Hospitals National Health Service Trust established by the Royal Hull Hospitals National Health Service Trust Establishment Order(**6**) are hereby dissolved, and accordingly those Orders are hereby revoked.
