**The Education (Funding for Teacher Training) Designation
(No. 2) Order 2000**

Made - - - - 5th July 2000

Laid before Parliament 6th July 2000

Coming into force 1st August 2000

In exercise of the powers conferred on the Secretary of State by section 4(2) of the Education Act 1994^(a), the Secretary of State for Education and Employment hereby makes the following Order:

1. This Order may be cited as the Education (Funding for Teacher Training) Designation (No. 2) Order 2000 and shall come into force on 1st August 2000.
2. The institutions and bodies referred to in the Schedule are hereby designated as institutions eligible for funding under Part I of the Education Act 1994.
