The Secretary of State for the Environment, Transport and the Regions, being designated(1) for the purpose of section 2(2) of the European Communities Act 1972(2) in relation to the regulation and supervision of the working conditions of persons engaged in road transport, in exercise of the powers conferred by that section, and of all other powers enabling him in that behalf, hereby makes the following Regulations:

#### Citation and commencement

**1.** These Regulations may be cited as the Community Drivers' Hours (Passenger and Goods Vehicles) (Temporary Exception) (Amendment) Regulations 2000 and shall come into force on 2nd October 2000.
