The Secretary of State for the Environment, Transport and the Regions makes this Order in exercise of powers conferred by sections 10 and 12 of the Highways Act 1980(**a**), and now vested in him (**b**) of all other enabling powers—

1. This Order shall come into force on 25th October 2000 and may be cited as the A30 Trunk Road (Honiton to Exeter Improvement) (Detrunking) (No. 2) Order 2000.

2. Those lengths of trunk road described in the Schedule to this Order and shown by reference to the Letters 'A' and 'B' on the deposited plan shall cease to be trunk road and shall be classified as classified roads as from the date on which this Order comes into force.

3. In this Order—
