Postal Services Act 2000 (Disclosure of Information) Order 2001

Made	6th November 2001
Laid before Parliament	9th November 2001
Coming into force	1st December 2001

The Secretary of State, in exercise of the powers conferred upon her by paragraph 4 of Schedule 7 to the Postal Services Act 2000(1), hereby makes the following Order:

Citation and Commencement

1. This Order may be cited as the Postal Services Act 2000 (Disclosure of Information) Order 2001 and shall come into force on 1 December 2001.

Modifications to Schedule 7

2.—(1) Paragraph 3 (other permitted disclosures) of Schedule 7 to the Postal Services Act 2000 is modified as follows.

(2) In sub-paragraph (1)(c), for "the Financial Services Act 1986(2)" substitute "the Financial Services and Markets Act 2000(3)".

(3) In sub-paragraph (2), delete paragraphs (h) and (l) and, at the end, add—

- "(s) the Financial Services Authority,
- (t) the Gas and Electricity Markets Authority,
- (u) the Gas and Electricity Consumer Council.".

(4) For sub-paragraph (3), substitute—

This Order modifies paragraph 3 of Schedule 7 to the Postal Services Act 2000. Paragraph 1 of Schedule 7 prohibits the disclosure of certain information obtained under the Act. Paragraph 2 permits the disclosure of that information with the consent of the person to whom it relates. Paragraph 3 sets out other circumstances in which disclosure is permitted.
