**The South Gloucestershire Primary Care Trust  
(Establishment) Order 2001**

*Made* - - - - - *20th February 2001*

*Coming into force* - - - *26th February 2001*

The Secretary of State for Health, in exercise of the powers conferred on him by sections 16A(1), (2) and (3) and 126(4) of, and paragraphs 1 and 2 of Schedule 5A to, the National Health Service Act 1977(a) and of all other powers enabling him in that behalf, following compliance with the consultation requirements contained in regulations made under section 16A(5) of the Act(b), hereby makes the following Order:

**Citation, commencement and interpretation**

1.—(1) This Order may be cited as the South Gloucestershire Primary Care Trust (Establishment) Order 2001 and shall come into force on 26th February 2001.

(2) In this Order, unless the context otherwise requires—

“the Act” means the National Health Service Act 1977;

“Executive Committee” has the meaning given in regulation 1(2) of the Membership Regulations;

“member”, “officer member” and “non-officer member” have the meanings given in regulation 1(2) of the Membership Regulations;

“Membership Regulations” means the Primary Care Trusts (Membership, Procedure and Administration Arrangements) Regulations 2000(c);

“operational date” is to be construed in accordance with paragraph 1(2) of Schedule 5A to the Act;

“preparatory period” is to be construed in accordance with paragraph 2(2) of Schedule 5A to the Act;

“the trust” means the South Gloucestershire Primary Care Trust established by article 2 of this Order.

### **Establishment and name of the Primary Care Trust**

2. There is hereby established a Primary Care Trust which is to be called the South Gloucestershire Primary Care Trust.

### **Area of the trust**

3. The trust shall be established for the area specified in the Schedule to this Order.

### **Members of the trust**

4.—(1) The trust shall have, in addition to the chairman, 5 officer members and 5 non-officer members.

(2) The non-officer members shall comprise the persons appointed by the Secretary of State under regulation 2(3) of the Membership Regulations.

(3) The officer members(a) shall comprise—

- (a) the persons who for the time being hold the offices of Chief Executive and Director of Finance of the trust;
- (b) the person who for the time being holds the post of chairman of the Executive Committee of the trust;
- (c) 2 persons appointed by the chairman of the trust following nomination by the Executive Committee of the trust.

### **Operational date of the trust**

5. The trust's operational date shall be 1st April 2001.

### **Limitations on the exercise of functions by the trust during the preparatory period**

6. During the preparatory period the exercise of functions by the trust shall be limited to the following—

- (a) entering into NHS contracts;
- (b) entering into other contracts including contracts of employment; and
- (c) doing such other things as are reasonably necessary to enable it to begin to operate satisfactorily with effect from the operational date.

### **Assistance during the preparatory period**

7.—(1) The Avon Health Authority shall meet the costs of the trust performing its functions during the preparatory period by discharging such of the liabilities of the trust incurred during that period as are of a description specified in paragraph (2) and do not in aggregate exceed such amount as may be notified by the Authority to the trust.

(2) The liabilities referred to in the preceding paragraph are—

- (a) liability for the remuneration and travelling or other allowances of the chairman and members of the trust;
- (b) liability for the travelling or other allowances of the members of committees and sub-committees of the trust who are not also members of the trust;
- (c) liability for the remuneration of officers of the trust; and
- (d) any other liability which may reasonably be incurred by the trust for the purpose of enabling it to begin to operate satisfactorily with effect from its operational date.

(3) The Avon Health Authority shall make available to the trust during the preparatory period—

- (a) premises and other facilities of the Authority; and
- (b) officers of the Authority.

- (a) premises and other facilities of the NHS trust; and
- (b) staff of the NHS trust.

### AREA OF TRUST

In the district of South Gloucestershire—

the electoral wards of Almondsbury, Alveston, Badminton, Bitton North Common, Bitton Oldland Common, Bitton South, Blackhorse, Bromley Heath, Charfield, Chase, Chiphouse, Chipping Sodbury, Dodington North, Downend, Filton Charborough, Filton Northville, Forest, Frampton Cotterell Central, Frampton Cotterell East, Frampton Cotterell West, Hanham, Hanham Abbots East, Hanham Abbots West, Hawkesbury, Iron Acton, Mangotsfield, Marshfield, New Cheltenham, Oldbury-on-Severn, Oldland Barrs Court, Oldland Cadbury Heath, Oldland Longwell Green, Olveston, Patchway Callicroft, Patchway Coniston, Patchway Stoke Lodge, Pilning and Severn Beach, Pucklechurch, Siston, Soundwell, Springfield, Staple Hill, Stoke Gifford North, Stoke Gifford South, Thornbury North, Thornbury South, Westerleigh and Coalpit Heat, Wick and Abson, Wickwar, Winterbourne, Winterbourne Down and Hambrook, Winterbourne Frenchay, Woodstock, Yate Central, Yate North, Yate South, Yate Stanshawes.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order establishes the South Gloucestershire Primary Care Trust (“the trust”), as provided for under section 16A of the National Health Service Act 1977. It specifies the area for which the trust is established (article 3 and the Schedule) and makes provision for the membership of the trust (article 4). It specifies the trust’s operational date (article 5); limitations on the exercise of its functions during its preparatory period (article 6) and makes provision for assistance to the trust during its preparatory period (article 7).
