**The Education (Student Loans) (Amendment) (No. 2)  
(England and Wales) Regulations 2002**

In exercise of the powers conferred by section 1(2)(b) and (7) of and paragraph 1(1) of Schedule 2 to the Education (Student Loans) Act 1990(a), the Secretary of State for Education and Skills hereby makes the following Regulations:—

**Citation, commencement and application**

1.—(1) These Regulations may be cited as the Education (Student Loans) (Amendment) (No. 2) (England and Wales) Regulations 2002 and shall come into force on 1st August 2002 immediately after the coming into force of the Education (Student Loans) (Amendment) (England and Wales) Regulations 2002(b).

(2) These Regulations do not apply in or as regards Scotland(c).

**Amendment of Regulations**

2. The Education (Student Loans) Regulations 1998(d) shall be amended as follows.

3. In regulation 6(1)(a), 6(2)(a) and 6(4) for the figure of £1,070 there shall be substituted the figure of £1,075.

## EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations, which come into force on 1st August 2002, amend the Education (Student Loans) Regulations 1998 governing loans made under the Education (Student Loans) Act 1990, which are mortgage style repayment loans made, for the most part, to students who began their courses before 1st August 1998.

These Regulations correct an error in the Education (Student Loans) (Amendment) (England and Wales) Regulations 2002 (S.I. 2002/1329) in the figures for the maximum amounts which may be lent to students in relation to their final academic year (regulation 3), and are issued free of charge to all known recipients of that Statutory Instrument.
