NATIONAL HEALTH SERVICE, ENGLAND

The West Yorkshire Health Authority
(Transfer of Trust Property) Order 2002

Made - - - - 4th September 2002
Laid before Parliament 5th September 2002
Coming into force - - 30th September 2002

The Secretary of State for Health, in exercise of the powers conferred on him by sections 92(1) and 126(4) of the National Health Service Act 1977(1) and of all other powers enabling him in that behalf, having regard to changes in the area and functions of the West Yorkshire Health Authority and having consulted that Health Authority, the Bradford District Care Trust and the Mid Yorkshire Hospitals National Health Service Trust in accordance with section 92(3) of that Act, hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the West Yorkshire Health Authority (Transfer of Trust Property) Order 2002 and shall come into force on 30th September 2002.

(2) In this Order—

“the old Trust” means the West Yorkshire Health Authority(2);

“the new Trust” means the Bradford District Care Trust(3) or the Mid Yorkshire Hospitals National Health Service Trust as the context requires(4);

“the trust property” means the property specified in the two schedules of trust property more specifically described in paragraphs (1) and (2) of article 2 of this Order.

As regards Wales, the functions of the Secretary of State under the above mentioned powers are transferred to the National Assembly for Wales under article 2(a) of the National Assembly for Wales (Transfer of Functions) Order 1999 S.I.1999/672 as amended by section 66(5) of the 1999 Act; this order therefore only extends to England.

Transfer of trust property

2.—(1) On 30th September 2002 the trust property specified in the schedule of trust property prepared and agreed upon by the old Trust and the Bradford District Care Trust and signed on behalf of both the old Trust and the Bradford District Care Trust on 16th July 2002, and any rights and liabilities arising from that property⁽⁵⁾, shall be transferred from the old Trust to the Bradford District Care Trust.

(2) On 30th September 2002 the trust property specified in the schedule of trust property prepared and agreed upon by the old Trust and the Mid Yorkshire Hospitals National Health Service Trust and signed on behalf of the old Trust on 16th July 2002 and on behalf of the Mid Yorkshire Hospitals National Health Service Trust on 17th July 2002, and any rights and liabilities arising from that property⁽⁶⁾, shall be transferred from the old Trust to the Mid Yorkshire Hospitals National Health Service Trusts.

3.—(1) In any trust instrument relating to the trust property, any reference to the name by which the trustees of the trust property are to be known shall be construed as a reference to the relevant new Trust and any reference to the old Trust in the name by which the charitable trust governing the trust property is to be known shall be construed as a reference to the relevant new Trust.

(2) In paragraph (1) of this article references to the relevant new trust are to be read as references to the new Trust to which the property which is the subject of the trust instrument has been transferred under article 2 of this Order.

EXPLANATORY NOTE
