**The Portsmouth Healthcare National Health Service
Trust (Transfer of Trust Property) Order 2002**

The Secretary of State for Health, in exercise of the powers conferred on him by sections 92(1) and (4) and 126(4) of the National Health Service Act 1977⁽¹⁾ and of all other powers enabling him in that behalf, having regard to changes or proposed changes in the administration of the Portsmouth Healthcare National Health Service Trust and having consulted that Trust, the West Hants National Health Service Trust and the Portsmouth City Primary Care Trust in accordance with section 92(3) of that Act, hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Portsmouth Healthcare National Health Service Trust (Transfer of Trust Property) Order 2002 and shall come into force on 1st April 2002.

(2) In this Order—

“the old Trust” means the Portsmouth Healthcare National Health Service Trust⁽²⁾;

“the new Trusts” means the West Hants National Health Service Trust⁽³⁾ and the Portsmouth City Primary Care Trust⁽⁴⁾;

“the trust property” means the property specified in the two schedules of trust property more specifically described in paragraphs (1) and (2) of article 2 of this Order.

Transfer of trust property

2.—(1) On 1st April 2002 the trust property specified in the schedule of trust property prepared and agreed upon by the old Trust and the West Hants National Health Service Trust and signed on behalf of the old Trust and on behalf of the West Hants National Health Service Trust on 23rd November 2001, and any rights and liabilities arising from that property⁽⁵⁾, shall be transferred from the old Trust to the West Hants National Health Service Trust.

(2) On 1st April 2002 the trust property specified in the schedule of trust property prepared and agreed upon by the old Trust and the Portsmouth City Primary Care Trust and signed on behalf of the old Trust and on behalf of the Portsmouth City Primary Care Trust on 20th November 2001, and any rights and liabilities arising from that property⁽⁶⁾, shall be transferred from the old Trust to the Portsmouth City Primary Care Trust.

3.—(1) In any trust instrument relating to the trust property, any reference to the name by which the trustees of the trust property are to be known shall be construed as a reference to the relevant new Trust and any reference to the old Trust in the name by which the charitable trust governing the trust property is to be known shall be construed as a reference to the relevant new Trust.

(2) In paragraph (1) of this article references to the relevant new Trust are to be read as references to the new Trust to which the property which is the subject of the trust instrument has been transferred under article 2 of this Order.
