**The Waltham Forest Primary Care
Trust (Establishment) Order 2003**

Made - - - - 21st March 2003

Coming into force - - 1st April 2003

The Secretary of State for Health, in the exercise of the powers conferred on him by sections 16A(1), (2) and (3) and 126(4) of, and paragraph 1 of Schedule 5A to, the National Health Service Act 1977(1) and of all other powers enabling him in that behalf, following compliance with the consultation requirements contained in regulations made under section 16A(5) of the Act(2), hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Waltham Forest Primary Care Trust (Establishment) Order 2003 and shall come into force on 1st April 2003.

(2) In this Order—

“operational date” is to be construed in accordance with paragraph 1(2) of Schedule 5A to the National Health Service Act 1977;

“the trust” means the Waltham Forest Primary Care Trust established by article 2 of this Order.

Establishment, operational date and name of the Primary Care Trust

2.—(1) There is hereby established a Primary Care Trust to be called the Waltham Forest Primary Care Trust.

(2) The operational date of the trust shall be 1st April 2003.
