**The Walsall Primary Care Trust (Change of Name)
Amendment Order 2003**

Made - - - - - *31st July 2003*

Coming into force *20th August 2003*

The Secretary of State for Health, in exercise of the powers conferred upon him by sections 16A(1) and (2) and 126(3) of, and paragraph 1 of Schedule 5A to, the National Health Service Act 1977(a), and of all other powers enabling him in that behalf hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Walsall Primary Care Trust (Change of Name) Amendment Order 2003 and shall come into force on 20th August 2003.

(2) In this Order—

“the Establishment Order” means the Walsall Primary Care Trust (Establishment) Order 2002(b); and

“the trust” means the Primary Care Trust established by the Establishment Order.

Change of name of the trust

2. The trust shall be called the Walsall Teaching Primary Care Trust instead of the Walsall Primary Care Trust, and accordingly—

(a) in article 1(2) of the Establishment Order (citation, commencement and interpretation), in the definition of “the trust”; and

(b) in article 2(1) of the Establishment Order (establishment, operational date and name of the Primary Care Trust),

“Walsall” shall be replaced by “Walsall Teaching”.

3. The change of name effected by article 2 of this Order shall not—

(a) affect any right or obligation of any person; or

(b) be taken as invalidating any instrument (whether made before, on, or after the day on which this Order comes into force) which refers to the trust by its previous name,

and all instruments and other documents which refer to the trust under its previous name shall be construed as referring to it under its new name.

The functions of the Secretary of State under these provisions are, so far as exercisable in relation to Wales, transferred to the National Assembly for Wales by article 2(a) of the National Assembly for Wales (Transfer of Functions) Order 1999, S.I. 1999/672, as amended by section 66(5) of the 1999 Act.

This Order amends the Walsall Primary Care Trust (Establishment) Order 2002, which established the Walsall Primary Care Trust.

Article 2 of the Order changes the name of the trust from the Walsall Primary Care Trust to the Walsall Teaching Primary Care Trust, and makes consequential amendments to the Establishment Order.
