The Brent Primary Care Trust (Change of Name) Amendment Order 2003

Made - - - - 7th October 2003

Coming into force - - 21st October 2003

The Secretary of State for Health, in exercise of the powers conferred upon him by sections 16A(1) and (2) and 126(3) of, and paragraph 1 of Schedule 5A to, the National Health Service Act 1977(a), and of all other powers enabling him in that behalf hereby makes the following Order:

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Brent Primary Care Trust (Change of Name) Amendment Order 2003 and shall come into force on 21st October 2003.
 - (2) In this Order—
 - "the Establishment Order" means the Brent Primary Care Trust (Establishment) Order 2002(**b**); and
 - "the trust" means the Primary Care Trust established by the Establishment Order.

Change of name of the trust

- **2.** The trust shall be called the Brent Teaching Primary Care Trust instead of the Brent Primary Care Trust, and accordingly—
 - (a) in article 1(2) of the Establishment Order (citation, commencement and interpretation), in the definition of "the trust"; and
 - (b) in article 2(1) of the Establishment Order (establishment, operational date and name of the Primary Care Trust),
 - "Brent" shall be replaced by "Brent Teaching".
 - 3. The change of name effected by article 2 of this Order shall not—
 - (a) affect any right or obligation of any person; or

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Brent Primary Care Trust (Establishment) Order 2002, which established the Brent Primary Care Trust.

Article 2 of the Order changes the name of the trust from the Brent Primary Care Trust to the Brent Teaching Primary Care Trust, and makes consequential amendments to the Establishment Order.
