# The City and Hackney Primary Care Trust (Change of Name) Amendment Order 2003

*Made - - - - 13th October 2003* 

Coming into force - - 4th November 2003

The Secretary of State for Health, in exercise of the powers conferred upon him by sections 16A(1) and (2) and 126(3) of, and paragraph 1 of Schedule 5A to, the National Health Service Act 1977(a), and of all other powers enabling him in that behalf hereby makes the following Order:

#### Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the City and Hackney Primary Care Trust (Change of Name) Amendment Order 2003 and shall come into force on 4th November 2003.
  - (2) In this Order—
    - "the Establishment Order" means the City and Hackney Primary Care Trust (Establishment) Order 2001(b); and
    - "the trust" means the Primary Care Trust established by the Establishment Order.

### Change of name of the trust

- **2.** The trust shall be called the City and Hackney Teaching Primary Care Trust instead of the City and Hackney Primary Care Trust, and accordingly—
  - (a) in article 1(2) of the Establishment Order (citation, commencement and interpretation), in the definition of "the trust"; and
  - (b) in article 2 of the Establishment Order (establishment and name of the Primary Care Trust),
  - "City and Hackney" shall be replaced by "City and Hackney Teaching".
  - 3. The change of name effected by article 2 of this Order shall not—
    - (a) affect any right or obligation of any person; or

and all instruments and other documents which refer to the trust under its previous name shall be construed as referring to it under its new name.

This Order amends the City and Hackney Primary Care Trust (Establishment) Order 2001, which established the City and Hackney Primary Care Trust.

Article 2 of the Order changes the name of the trust from the City and Hackney Primary Care Trust to the City and Hackney Teaching Primary Care Trust, and makes consequential amendments to the Establishment Order.
