**The Tobacco Advertising and Promotion Act 2002
(Commencement No. 6) Order 2003**

Made - - - - *25th February 2003*

The Secretary of State for Health in exercise of the powers conferred on him by section 22(1) of the Tobacco Advertising and Promotion Act 2002^(a) and all other powers enabling him in that behalf, hereby makes the following Order:—

Citation, interpretation and extent

- 1.—(1) This Order may be cited as the Tobacco Advertising and Promotion Act 2002 (Commencement No.6) Order 2003.
- (2) In this Order “section” means a section of the Tobacco Advertising and Promotion Act 2002.
- (3) This Order applies to England, Wales and Northern Ireland only.

Appointed day

2. 26th February 2003 is the appointed day for the coming into force of—
 - (a) section 4(3) and (4),
 - (b) section 11(1) to (3), and
 - (c) section 20so far as not already in force.
