The Education Act 2002 (School Meals) (Consequential Amendments) (England) Regulations 2003

In exercise of the powers conferred on the Secretary of State by section 214 of the Education Act 2002(a) the Secretary of State for Education and Skills hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Education Act 2002 (School Meals) (Consequential Amendments) (England) Regulations 2003 and shall come into force on 11th April 2003.

Amendment of the Education (Transfer of Functions Concerning School Lunches etc) (England) (No. 2) Order 1999

2. The Education (Transfer of Functions Concerning School Lunches etc) (England) (No. 2) Order 1999(b) is amended as follows –

- (a) in article 2(2)(a), for “section 512(1A) and (1B)” there is substituted “section 512(3) and (4)”;
- (b) in article 2(2)(b), for “section 512(3)” there is substituted “section 512ZB(1)”;
- (c) article 2(3) is revoked;
- (d) in article 3(1), for “section 512(3)(b)” there is substituted “section 512ZB(3)”;
- (e) in article 4(1) and (2), for “section 512(2)(b)” there is substituted “section 512ZA(2)”.

Amendment of the Education (Information About Individual Pupils) (England) Regulations 2001

3. In paragraph 6 of Part 1 of the Schedule to the Education (Information About Individual Pupils) (England) Regulations 2001(c), for “section 512(3) and (3A)” there is substituted “sections 512(3) and 512ZB”.
