# PENSIONS

The Personal Injuries (Civilians) (Amendment) Scheme 2004

Made	10th March 2004
Laid before Parliament	12th March 2004
Coming into force	12th April 2004

The Secretary of State for Defence, with the approval of the Treasury, in exercise of the powers conferred by sections 1 and 2 of the Personal Injuries (Emergency Provisions) Act 1939(1) and now vested in him(2), and of all other powers enabling him in that behalf, hereby makes the following Scheme:

#### Citation, commencement and interpretation

**1.**—(1) This Scheme may be cited as the Personal Injuries (Civilians) (Amendment) Scheme 2004 and shall come into force on 12th April 2004.

(2) In this Scheme, "the principal Scheme" means the Personal Injuries (Civilians) Scheme 1983(3), and, except where the context otherwise requires, a reference to a numbered article, Part, Table or Schedule is to the article, Part, Table or Schedule in the principal Scheme which bears that number.

#### Amendments to the principal Scheme and application

**2.** The amendments to the principal Scheme contained in Schedule 1 to this Scheme shall have effect.

## AMENDMENTS TO THE PRINCIPAL SCHEME

#### Amendment of article 26A

- 1. In article 26A (funeral expenses)—
- (1) in paragraph (1)—
  - (a) in subparagraph (a) at the end insert "and";
  - (b) in subparagraph (b) at the beginning insert the words "that person's funeral has taken place, providing that where the date of the funeral is on or before 11th April 2004";
  - (c) omit the words ", including the cost of transporting the person's body but only within the area of the British Islands and the Republic of Ireland".
- (2) in paragraph (2)—
  - (a) at the beginning insert the words "Subject to paragraph (3),";
  - (b) omit the words ", and after deduction of any amount payable in respect of death benefit in the Isle of Man or any of the Channel Islands";
  - (c) for subparagraph (b) substitute—
    - "(b) transportation of the body, but for funerals taking place on or before 11th April 2004 transportation only within the British Islands and the Republic of Ireland;";
  - (d) for subparagraph (c) substitute—
    - "(c) travelling costs of one return journey by the person responsible for the funeral to attend or arrange the funeral, but for funerals taking place on or before 11th April 2004 only travelling costs of one return journey within the British Islands or the Republic of Ireland;";
  - (e) at the end insert—

"(3) In the case of a funeral which takes place on or after 12th April 2004, the reasonable funeral expenses shall not exceed a total of  $\pounds$ 1400."

#### Substitution of Schedules 3,4 and 7 to the principal Scheme

**2.**—(1) For Schedules 3 and 4 to the principal Scheme (rates of pensions and allowances payable in respect of disablement and death) there shall respectively be substituted the Schedules set out in Schedule 2 to this Scheme and numbered 3 and 4.

(2) For Schedule 7 to the principal Scheme (deductions for the purposes of article 64) there shall be substituted the table set out in Schedule 3 to this Scheme.

#### **EXPLANATORY NOTE**

#### (This note is not part of the Scheme)

This Scheme further amends the Personal Injuries (Civilians) Scheme 1983 ("the principal Scheme") which makes provision for the payment of pensions and allowances to or in respect of civilians who were killed or injured during the 1939-45 World War by increasing the amounts of allowances, pensions and awards payable under the principal Scheme and the amounts of income to be disregarded for the purposes of certain parts of the Scheme.

Paragraph 1 of Schedule 1 amends article 26A (funeral expenses) in the principal Scheme to allow funeral expenses to be paid in respect of funerals which take place on or after 12th April 2004 outside the British Islands and the Republic of Ireland. It also amends the article so that a maximum of £1400 is applied to the funeral expenses which may be payable in respect of all funerals which take place on or after 12th April 2004.

Sub-paragraph 2(2) of Schedule 1 amends Schedule 7 to the principal Scheme by substituting a new table, thereby varying the amounts to be deducted under article 64. Unemployability allowance will be subject to deduction under article 64 on or after 12th April 2004 after a period of 52 weeks hospitalisation rather than 13 weeks.
