The County of Norfolk (Electoral Changes) Order 2005

Made - - - - 1st February 2005 Coming into force in accordance with article 1(2) and 1(3)

Whereas the Boundary Committee for England(1), acting pursuant to section 15(4) of the Local Government Act 1992(2), has submitted to the Electoral Commission(3) recommendations dated October 2004 on its review of the county of Norfolk:

And whereas the Electoral Commission have decided to give effect, with one modification, to those recommendations:

And whereas a period of not less than six weeks has expired since the receipt of those recommendations:

Now, therefore, the Electoral Commission, in exercise of the powers conferred on them by sections 17(4) and 26(5) of the Local Government Act 1992, and of all other powers enabling them in that behalf, hereby make the following Order:

Citation and commencement

- 1.—(1) This Order may be cited as the County of Norfolk (Electoral Changes) Order 2005.
- (2) This Order, with the exception of article 4, shall come into force
 - (a) for the purpose of proceedings preliminary or relating to any election to be held on the ordinary day of election of councillors in 2005, on the day after that on which it is made;
 - (b) for all other purposes, on the ordinary day of election of councillors in 2005.
- (3) Article 4 shall come into force –

- (a) for the purpose of proceedings preliminary or relating to the election of a parish councillor for the parish of Sprowston to be held on the ordinary day of elections in 2007, on 15th October 2006;
- (b) for all other purposes, on the ordinary day of elections in 2007.

Interpretation

2. In this Order –

"county" means the county of Norfolk;

"existing", in relation to an electoral division or ward, means the electoral division or ward as it exists on the date this Order is made;

references to wards, unless the context otherwise requires, are references to district, borough and city wards in the county(6);

any reference to the map is a reference to the map marked "Map referred to in the County of Norfolk (Electoral Changes) Order 2005", of which prints are available for inspection at –

- (a) the principal office of the Electoral Commission; and
- (b) the offices of Norfolk County Council; and

any reference to a numbered sheet is a reference to the sheet of the map which bears that number.

Electoral divisions of the county of Norfolk

- **3.**—(1) The existing electoral divisions of the county(7) shall be abolished.
- (2) The county shall be divided into eighty-four electoral divisions which shall bear the names set out in column (1) of the Schedule.
- (3) The electoral divisions shall comprise the areas described in column (2) of the Schedule by reference to wards, parishes, or parish wards or, where an area is not so described, the area designated on the map by reference to the name of the electoral division and demarcated by red lines; and the number of councillors to be elected for each electoral division shall be one.
- (4) Where a boundary is shown on the map as running along a road, railway line, footway, watercourse or similar geographical feature, it shall be treated as running along the centre line of the feature.

Wards of the parish of Sprowston

- **4.**—(1) The existing wards of the parish of Sprowston shall be abolished.
- (2) The parish shall be divided into four parish wards which shall bear the names Sprowston Central, Sprowston North East, Sprowston South East and Sprowston West; and the wards shall comprise the areas designated on sheet 2 by reference to the name of the ward and demarcated by orange lines.
- (3) The number of councillors to be elected for the Sprowston South East parish ward shall be seven, for the Sprowston Central parish ward shall be five, for the Sprowston West parish ward shall be two, and for the Sprowston North East parish ward shall be one.

Electoral registers

6. The Electoral Registration Officer(**8**) for each district, borough or city in the county shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

Revocation

7. The County of Norfolk (Electoral Arrangements) Order 1984(9) is revoked, save for article 5.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order gives effect, with one modification, to recommendations by the Boundary Committee for England, a committee of the Electoral Commission, for electoral changes in the county of Norfolk.

The modification concerns the name of North Walsham West and Erpingham electoral division.

The changes have effect in relation to local government elections to be held on and after the ordinary day of election of councillors in 2005.

Article 3 abolishes the existing electoral divisions of the county and provides for the creation of 84 new electoral divisions. That article and the Schedule also make provision for the names and areas of, and numbers of councillors for, the new electoral divisions.

Article 4 makes electoral changes in the parish of Sprowston.

Article 6 obliges the Electoral Registration Officer for each district, borough or city in the county of Norfolk to make any necessary amendments to the electoral register to reflect the new electoral arrangements.

Article 7 revokes the County of Norfolk (Electoral Arrangements) Order 1984, with the exception of article 5.

The areas of the new electoral divisions and of the new parish wards of the parish of Sprowston are demarcated on the map described in article 2. Prints of the map may be inspected at all reasonable times at the offices of Norfolk County Council and at the principal office of the Electoral Commission at Trevelyan House, Great Peter Street, London SW1P 2HW.
