The Lord Chancellor, in exercise of the powers conferred upon him by section 97(5) of the Courts Act 2003(a) hereby makes the following Order:

**Citation and commencement**

1. This Order may be cited as the Collection of Fines (Pilot Schemes) (Amendment No. 3) Order 2005 and shall come into force on the 26th September 2005.
