The Serious Organised Crime and Police Act 2005 (Commencement No. 4 and Transitory Provision) Order 2005

 - (s) section 174(1) (minor and consequential amendments, repeals and revocations) and Schedule 16 (remaining minor and consequential amendments (search warrants));
 - (t) section 174(2) (minor and consequential amendments, repeals and revocations) in so far as it relates to the entries in Schedule 17 in paragraph (u) below; and
 - (u) in Part 2 of Schedule 17 (repeals and revocations), the entries relating to—
 - (i) the Unlawful Drilling Act 1819(1);
 - (ii) the Vagrancy Act 1824(2);
