Provisions coming into force on 1st October 2006

- 2. The following provisions of the 2006 Act shall come into force on 1st October 2006—
 - (a) section 11 in so far as it relates to paragraph 16(3) of Schedule 1 to the 2006 Act;
 - (b) Schedule 1, paragraph 16(1) in so far as it relates to paragraph 16(3) of Schedule 1; and
 - (c) Schedule 1, paragraph 16(3).
