The Lord Chancellor makes the following Order in exercise of the powers conferred upon him by section 107(6) of the Constitutional Reform Act 2005(a)—

**Citation and Commencement**

1. This Order may be cited as the Permitted Persons (Designation) Order 2006 and shall come into force on 3rd April 2006.
