The District of South Northamptonshire
(Electoral Changes) (Amendment) Order 2007

Made - - - - 25th January 2007

Coming into force in accordance with article 1(2)

The Electoral Commission⁽¹⁾, in exercise of the powers conferred by sections 17(2) and 26(3) of the Local Government Act 1992, make the following Order:

Citation and commencement

1.—(1) This Order may be cited as the District of South Northamptonshire (Electoral Changes) (Amendment) Order 2007.

(2) This Order comes into force on the day after that on which it is made.

Amendment to the 2006 Order

2.—(1) The District of South Northamptonshire (Electoral Changes) Order 2006⁽⁴⁾ shall be amended as follows:

(2) In article 2 the words “Revised (2007) Map referred to in the District of South Northamptonshire (Electoral Changes) Order 2006” shall be substituted for the words “Map referred to in the District of South Northamptonshire (Electoral Changes) Order 2006”.

(1) The Electoral Commission was established by the Political Parties, Elections and Referendums Act 2000 (c.41). The functions of the Secretary of State, under sections 13 to 15 and 17 of the [Local Government Act 1992 Act \(c.19\)](#), to the extent that they relate to electoral changes within the meaning of that Act, were transferred with modifications to the Electoral Commission by the Local Government Commission for England (Transfer of Functions) Order 2001 (S.I. 2001/3962).

(2) [1992 c.19](#). This section has been amended by [S.I. 2001/3962](#) and also otherwise in ways not relevant to this Order.

(3) This section has been amended by [S.I. 2001/3962](#).
