The Cambridgeshire and Peterborough Mental Health Partnership National Health Service Trust (Transfer of Trust Property) Order 2008

Made - - - - 19th May 2008

Laid before Parliament 23rd May 2008

Coming into force - - 1st July 2008

The Secretary of State for Health makes the following Order in exercise of the powers conferred by sections 213, 217(2) and 272(8) of the National Health Service Act 2006(1), having regard to changes in the functions of the Norfolk Primary Care Trust(2).

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Cambridgeshire and Peterborough Mental Health Partnership National Health Service Trust (Transfer of Trust Property) Order 2008 and shall come into force on 1st July 2008.
 - (2) In this Order—

"the old Trust" means the Cambridgeshire and Peterborough Mental Health Partnership National Health Service Trust(3);

"the new Trust" means the Norfolk Primary Care Trust;

"the trust property" means the property specified in the schedule of trust property prepared and agreed by the old Trust and the new Trust and signed on behalf of the old Trust on 2nd April 2008 and on behalf of the new Trust on 10th April 2008.

Transfer of trust property

2.—(1) On the date that this Order comes into force the trust property, and any rights and liabilities arising from that property, shall be transferred from the old Trust to the new Trust.
